Subject: Reservation to Scheduled Tribes in the jobs under Govt. of NCT of Delhi.

Sir,

Please refer to the reference made to Services Department in the file bearing No.F.55(12)/2001/Exam./DSSSB of the Board regarding eligibility of Scheduled Tribe candidates from other States/Union Territories for recruitment in the jobs under Govt. of NCT of Delhi and reply dated 10.8.2001 of Services Department (Annexure-I) wherein it had been stated that no list of Scheduled Tribes has been notified for Delhi under Article 342 of the Constitution, therefore a reference is being made to the Ministry of Home Affairs, Govt. of India seeking clarification as to how 7.5 % reservation for Scheduled Tribes can be ensured in the absence of any notified list of Scheduled Tribes for Delhi.

This issue was discussed in the meeting held on 29.8.2001 in the National Commission for Scheduled Castes & Scheduled Tribes. In the minutes of the said meeting, it has been advised that all the communities in the country notified as Scheduled Tribes in respect of various States/Union Territories would be eligible for consideration against the posts reserved for Scheduled Tribes under Govt. of NCT of Delhi.

In this regard, I am directed to inform that in pursuance of advice of the National Commission for Scheduled Castes & Scheduled Tribes, this Government has examined the matter and has decided that the benefit of reservation shall be given to Scheduled Tribe candidates in the jobs under Govt. of NCT of Delhi irrespective of their nativity as it had been given earlier.

It is, therefore, requested to ensure that all the communities in the country notified as Scheduled Tribes in respect of various States/Union Territories are considered against the posts reserved for Scheduled Tribes under Govt. of NCT of Delhi.

This issues with the prior approval of Lt. Governor, Delhi.
