Rape and harassment of 25 tribal girls of Hmar Tribe from Churachandpur District, Manipur by the cadres of UNLF and KCP

1. The Chairman in- charge of Lungthulian village, Parbung Sub-Division alleged that in the night of 16/1/2006 at about 8.45 p.m. about 20(twenty) UNLF and KCP cadres entered Lungthulian village by exploding bombs, firing several rounds and beating the villagers with firewood, etc. and thereafter, the UG cadres selected some young girls, started man handling/molesting them. Further, the Chairman in-charge also lodged complaints with Parbung Police Station about the alleged rape of girls of village by the UG cadres on the same night (16/1/2006). On receipt of the reports, the State Pclice registered 25(twenty five) FIR cases for investigation. These cases were registered long past the date of occurrence as the matter came to light only after the victims fled Parbung Sub-Division of Churachandpur District, Manipur towards Mizoram and highlighted the issue under the Hmar Students Organizations and other civil organizations. The act of brutality by the cadres of UNLF/KCP is the retaliation of the fight between the armed cadres of HPC(D) and UNLF for area domination.
2. The Sate Government on March 17, 2006 appointed a Commission of inquiry presided over by Justice S.P. Rajkhowa(Retd) for the purpose of making an enquiry into the matter. The Commission submitted its report to the Hon'ble Chief Minister, Manipur on 31/5/2008.
3. All 25 cases registered in connection with the above incidents are still under investigation. As it aliiegedly involved underground cadres of UNLF and KCP, the identity of the culprits could not be established from examination of the victims and other PWs, and as such, arrest of the culprits could not been made. Moreover, since the incidents were reported late, no sample/exhibit could be collected for scientific examination.
4. During the month of January, 2006, a combined team of Army and Assam Rifles launched an operation against the underground elements in Parbung area and killed 9(nine) unidentified UGs. The possibility of the accused persons of the rape cases among those killed in the operation can not be ruled out in those circumstances. Since 2006 to till date, 103 underground cadres including 44 cadres of UNLF and 6 cadres of KCP have been arrested by the District Police in various cases. However, the involvement of these cadres in the rape cases could not be established so far. All out efforts have been made to identify the culprits and cause their arrest by launching counter insurgency operations with the assistance of Army at Parbung areas and its surrounding villages – Tuolbung, Taihu, Damdiei, Pherzawl and border areas of Myanmar and Mizoram, but none of the culprits involved in the cases could be arrested as they had already fled away form the area after committing the crime. The whereabouts of the accused persons are not traceable as they belonged to UNLF and KCP underground organizations. It is also very difficult to locate their hideouts due to a terrain barrier. Moreover, there is no proper road from one village to another and the area is hilly, covered by thick jungle. Brief of the cases is enclosed as Annexure – A.

Brief: - On 16/3/2006 at 6.05 p.m. Shri Lalkapthoum, Chairman, Lungthulian Viallge Authority lodged a written complaint with Officer-in-Charge, Parbung Police Station stating that on 16/1/2006 at about 8.45 p.m. a combined armed non-tribal underground militants entered Lungthulian village and started exploding bombs and fired rounds in the air and started terrorizing the innocent public, while the harassment and torture was going on, some militants locked up Mrs. Thangthakim (30) w/o Buonglienkung and raped her at gun-point. Brief: - On 16/3/2006 at 6.05 p.m. Shri Lalkapthoum, Chairman, Lungthulian Viallge Authority lodged a written complaint with Officer-in-Charge, Parbung Police Station stating that on 16/1/2006 at about 8.45 p.m. a combined armed non-tribal underground militants entered Lungthulian Village and started exploding bombs and fired rounds in the air and started terrorizing the innocent public. While the harassment and torture was going on, some militants locked up Miss. Zothakim (19) d/o Raldosan and raped her. On examination of Mr. Raldosan (45) father of Miss Zothakim, he stated that on the night of 16/1/2006 when they were rounded up by the militants, one of them pulled her out. She returned back home next morning with bleeding injury on her forehead. Hence the case.

Brief: - On 16/3/2006 at 6.05 p.m. Shri Lalkapthoum, Chairman, Lungthulian Viallge Authority lodged a written complaint with Officer-in-Charge, Parbung Police Station stating that on 16/1/2006 at about 8.45 p.m. a combined armed non-tribal underground militants entered Lungthulian Village and started exploding bombs and fired rounds in the air and started terrorizing the innocent public. While the harassment and torture was going on, some militants locked up Miss. Ngurnenieng (19) d/o Zolien of Lungthulian Village and raped her at one corner of the village. On examination of Miss. Brief: On 16/3/2006 at 6.20 pm Shri Ralkapthouom, Chairman, Lungthulien Village Authority lodged a written complaint with Officer- in-Charge, Parbung Police Station stating that on 16/1/2006 at about 8.45 pm. Combined armed non-tribal underground militants entered Lungthulien village and started exploding bombs and fired rounds in the air and started terrorizing the innocent public. While the harassment and torture was going on, some militants locked up Miss Chinngaihchin (20) d/o Khamkam of Lungthulien village, and raped her in a secluded place in the village. On examination of the victim Chinngaihchin d/o khamkam, she stated that on the night of 16/1/2006 at about 9.00 pm while she was in the bed for sleep, she heard the sound of bombs and gun- shots. Then, a tall militant with black scarf on his head came inside her house and asked the members of the family to go out of the house. Then, the militants started beating them one after another. They also slapped her on her face. Hence the case.

Brief: On 17/4/2006 at 2.00 pm Shri L. Thuomiui (34) s/o Suokham, Secretary of Tuolbung Village Authority PS Parbung lodged a written complaint with Officer- in- Charge, Parbung Police Station stating that on 20/09/2005 at about 7.30 pm, some non- tribal armed militants belonging to UNLF cadres forcibly pulled out one Miss Lalninghak (14) d/o Laihmunthang of Tuolbung village into the house of Mr. Sangvung of Tuolbung village and then allegedly raped her. On examination of the victim Miss Lalninghak (14)d/o Lalhmunthang of Tuolbung village, she stated that in the evening of 20/9/2005 she was watching TV in the house of Mr. Loia, Village Authority Chairman. At about 7.30 pm she left for her house and on the way one armed UNLF militant holding a small gun caught hold of her and pulled her inside an empty house of Mr. Sangvung. There the militant stripped her and raped her. Hence the case.

- (17) FIR No. 27 (4) 2006 PBG PS u/s 354/121/121-A IPC, 20 UA (P) A Act, 25 (1-B) A Act and 3(I) (III) SC &ST (POA) Act.

Brief: On 17/4/2006 at 2.05 pm Shri Tlanlothang (55) s/o (L) Bula of Parbung village, Chairman of Parbung Village Authority lodged a written complaint with Officer- in-Charge Parbung Police Station stating that on 17/1/2006 at about 9 am one non-tribal armed militant suspected to be UNLF cadre molested Miss Lalkhawpui (22) D/O Zothanglur of Parbung village at her residence. On examination of the victim Miss Lalkhawpui (22) d/o Zothanglur of Parbung village, she stated that on 16/1/2006 at about 9.30 am while her parents were out to attend anniversary celebration of Mr. Khala, she was alone and cleaning her house. Then, one UNLF militant by the name S.K. pulled her and persuaded to have sex with him. Then, S.K. caught her and tried to kiss her and grabbed her parts and tried to rape her. But she resisted and escaped. Hence the case.

Brief: On 17/4/2006 at 2.10 pm Shri Tlanlothang (55) s/o (L) Bula of Parbung village, Chairman of Parbung Village Authority lodged a written complaint with Officer- in-Charge, Parbung Police Station stating that on 6/1/2006 at about 10.00 pm there was an encounter between HPC(D) and the combined non-tribal, armed militants of UNLF/KCP at Parbung. When the encounter was over, some of the non-tribal militants pulled out Miss Lalhangpui (25) d/o Paulsiemien of Parbung village and assaulted and molested her. On examination of the victim Miss Lalhangpui (25) d/o Paulsiemien of Parbung village, she stated that on 6/1/2005 after the encounter between HPC (D) and combined non-tribal militants of UNLF/KCP was over, one non-tribal militant came in her house, and dragged her out and molested her and attempt to rape in front of the house of Malsawm, but she resisted escaped. Hence the case.

- (19) FIR No.29 (4) 06 PBG PS u/s 354/326/121/121-A IPC, 20 UA (P) A Act, 25(1-B) A Act & 3(I) (III) SC &ST (POA) Act,

Brief: On 17/4/2006 at 2.15 p.m. Shri Tlanlothang (55) s/o (L) Bula of Parbung village, Chairman of Parbung Village Authority lodged a written complaint with Office-in-charge, Parbung Police Station stating that on the night of 18/1/2006, one armed non-tribal militant entered the house of (L) Mr. H.T. Thouma of Parbung village and forcibly pulled out his daughter Miss. Lalhlunkim (25) and assaulted and molested her. On examination of the victim Miss Lalhlunkim (25) d/o (L) Mr. H.T. Thouma of Parbung village, she stated that on night of 18/1/2006 at about 7.30 p.m. while she was sleeping in her room with cold and fever, suddenly one armed non-tribal militant who called himself S.K. came inside the house and forcibly asked her to accompany him outside. When she refused, S.K. started grabbing, holding and caressing her all over and tried to rape her. So, she struggled and ran out of her house and ran to the house of her neighbour and escaped. Hence the case.

- (20) FIR No.30 (4) 06 PBG PS u/s 354/326/121/121-A IPC, 20 UA (P) A Act, 25(1-B) A Act & 3(I) (III) SC &ST (POA) Act,

Brief: On 17/4/2006 at 2.15 p.m. Shri Tlanlothang (55) s/o (L) Bula of Parbung village, Chairman of Parbung Village Authority lodged a written complaint with Office-in-charge, Parbung Police Station stating that on the night of 18/1/2006 one armed non-tribal militant entered the house of Mr Darlenthang of Parbung village and forcibly molested and tried to rape his daughter Miss. Chawngrongai (22). On examination of the victim Miss Chawngrongai (22) d/o Darlenthang of Parbung village, she stated that on night of 18/1/2006 at about 8.00 p.m. one non-tribal who called himself M. Meiramba came inside her house and forcibly embrace her and proposed to have sex. When she refused, Mr. Meiramba grabbed her feminine parts and caressed her, but struggled and managed to escape later on. Hence the case.

Brief:- On 17/4/2006 at 2.25 p.m. Shri Tlanlothang (55) s/o (L) Bula of Parbung village, Chairman of Parbung Village Authority lodged a written complaint with Office-in-charge, Parbung Police Station stating that on the night of 18/1/2006 at 8.00 p.m., one Miss Lalrammawi (14) d/o Parasang of parbung was pulled down from a truck by non-tribal armed UNLF militants at Elim village and raped her. On examination of the victim Miss Lalrammawi (14) d/o Parasang of Parbung village, she stated that she went to Churachandpur during the month of January, 2006 for the purpose of searching admission in schools. When she was on her way back to home at Parbung in a truck, about 14 non-tribal armed militants stopped their truck at Elim. All the passengers were confined in a house there. At about 8 p.m. she was selected by one armed militants and forcibly taken to the next house and raped her. Hence the case.

On examination of the victim Miss Roneipui (22) d/o Sumtuothang of Parbung village, she stated that on the night of 18/1/2006 at @ 6.30.00 pm, one bald headed militant belonging to UNLF came to her house and proposed her to meet him at Jubilee Standard School. When she declined it, he forcibly hold her, grabbed her and tore her shirt, she resisted and struggled and ran up to the first floor and escaped. Hence the case.
