Shri P.R. Nagar has alleged regarding harassment and used derogatory caste based remarks by Smt. Vimla w/o Shri Naresh Gupta and others.

An enquiry has been conducted into the matter. During the enquiry on 13.5.2010 ACP/Vasant Vihar hold a meeting with Shri P.R. Nagar (complainant) in his office. During the meeting, the complainant told that the matter of differences and adversing cropped up while the complainant was candidate in the election of Sarpanch at Village Beejawar Chauhan, Tehsil Mundawar, Distt. Alwar, Rajasthan against Mr. Kedar Singh (a retired teacher) At that time, the complainant promised to come later to give his statement.

On 19.5.2010 Shri P.R. Nagar (complainant) came and submitted his written statement. The complainant stated that he want to inform the Commission about the incident that happened during election process in the month of February, 2010 in Rajasthan. He did not want action on the same, he still had apprehension about security of his family members at his native place. The complainant has stated that he did not want action on his complaint.

At this stage, no police action is warranted as the area falls in the jurisdiction of District Alwar of Rajasthan. Moreover, the complainant has given in writing that he does not want any action on his complaint.
