**Proceedings of the Sitting held on 23.02.2011 of Shri Bheru Lal Meena, Hon'ble Member with MCD**

**ISSUE**

Representation of Shri Om Prakash Meena, Tehsil – Sekrai, Dousa, Rajasthan regarding corruption charges against Shri Lalit Sharma, LDC of Recruitment Section, Education Department (Hq.), MCD, Kashmiri Gate, Delhi.

**BACKGROUND**

A representation dated Nil was received in the Commission on 18/06/2010 from Shri Om Prakash Meena S/o Shri Ram Srup Meena, Tehsil-Sekrai, Dousa, Rajasthan regarding corruption charges against Shri Lalit Sharma, LDC of Recruitment Section, Education Department (Hq.), MCD, Kashmiri Gate, Delhi. It was mentioned in the representation that Shri Meena along with his friends was selected by Delhi State Service Selection Board as Primary Teacher in MCD under the post code 165/07. He further mentioned that the file of their appointment was returned by the Central Zone, Lajapat Nagar to Hq with some objections. Shri Meena also stated that Shri Lalit Sharma, LDC working in the Headquarter and dealing with the case demanded the money to get the objection cleared, which was allegedly paid by them. It was alleged that Shri Sharma kept on demanding the money and at last Shri Meena and his friends refused to pay and asked to refund the money paid by them. Shri Sharma refused to refund the money and threatened and abused them. Shri Meena is requesting the matter be investigated and they should get their money back.

The matter was taken up with the Commissioner, Municipal Corporation of Delhi vide letter dated 18/06/2010 and followed by reminders dated 09/08/2010, 09/09/2010 and 12/10/2010.

Since no reply received from MCD, Shri Bheru Lal Meena, Hon'ble Member decided to hold a Sitting/discussion on 23/02/2011 at 1130 hrs with the Commissioner, MCD in the Commission.

## DISCUSSION

The Commission explained the background of the case in brief. MCD officials informed that verification of documents submitted by the applicants and inquiry into the case is being done by them. Shri Om Prakash Meena was called by the MCD officials to get the details about the complaint. Shri Meena informed them that the signature on the complaint is not his and had confirmed in writing. A team of officers constituted by the MCD to verify the documents submitted by the candidates visited the Samath, Varanasi, from where the Certificate of DIET was obtained. It was intimated by the institute to the team of officers that the exam was not conducted for the last 10 years, therefore, there was no certificate issued during this period.

## RECOMMENDATION

In view of the discussion, the Commission recommended that a detailed report on the action taken or proposed by the MCD in the matter with supporting documents be submitted within 15 days for perusal of the Commission.
