Sub: Review of Constitutional Safeguards for Scheduled Tribes.

Sir,

The National Commission for Scheduled Tribes (NCST) has been set up under Article 338A of the Constitution of India vested with responsibility, inter-alia to investigate and monitor all matters relating to the safeguards provided to the Scheduled Tribes under the Constitution or under any other law for the time being in force or under any order of the Government and to monitor and evaluate the working of such safeguards. The NCST is required to present to the Hon'ble President of India, annually and at such other times as the Commission may deem fit, reports upon the working of those safeguards.

- 2. Accordingly, the NCST has decided to review the implementation of Constitutional safeguards including reservation policy in respect of your organization on 14/06/2018 at 3:00 P.M., Conference Hall, National Commission for Scheduled Tribes, 6<sup>th</sup> Floor, Lok Nayak Bhawan, Khan Market, New Delhi-110003.
- 3. The NCST has evolved a questionnaire for review, a copy of the same is enclosed for furnishing replies / information by your Organization. The replies to various issues covered under the questionnaire will form the basis for review meeting. It is requested that replies / information in respect of questionnaire may be prepared and furnished under your seal and signature to this Commission before 08/06/2018. A soft copy of the replies to the questionnaire may also be sent to js@ncst.nic.in and ds.admn@nic.in for record. A brief presentation along with measures / programmes taken up by Gas Authority India Ltd. for welfare of Scheduled Tribes in the country may also be made during the review meeting before the Commission.
- 4. It has also been decided that the Commission will discuss the issue of grievances of Scheduled Tribes employees of Gas Authority of India Ltd. on 14/06/2018 at 2:00 P.M. with association of ST employees of Gas Authority India Ltd. before the review meeting.
- 5. It is, accordingly, requested to inform the association of ST employees of the Gas Authority India Ltd. to attend the meeting on 14/06/2018 at 2:00 P.M. in the Conference Hall of NCST. The Liaison Officer Gas Authority of India Ltd. for STs may be asked to attend the review meeting on 14/06/2018.
