Subject: Filling up of one post of Director(Investigation), on deputation basis, in the National Commission for Scheduled Tribes (NCST)- regarding.

Sir / Madam,

I am directed to say that it is proposed to fill up one (1) post of Director(Investigation), Group `A`, in Level 12 (Rs. 78800-209200) of the 7th CPC Pay Matrix, on deputation basis, in the National Commission for Scheduled Tribes. The post is located at New Delhi.

2. Job requirement, experience and qualification required for the post are as under:

Job requirement:

The incumbent of the post is required to assist the Commission in inquiring into specific complaints with respect to the deprivation of rights and safeguards of Scheduled Tribes and related issues.

Eligibility Conditions:

A. Essential:

Officers of the Central Government, State Governments/ Union Territories/ PSUs/ Constitutional Bodies/ Autonomous bodies/ Statutory bodies, Universities or Recognized Research Institutions:

(i) holding analogous post on regular basis; or

(ii) with 5 years' regular service in posts in Level 11 of the 7th CPC pay matrix (67700-208700) or equivalent in the parent cadre or Department.

B. Desirable:

(i) Possessing a Master's Degree of a recognized university preferably in Sociology, Anthropology, Political Science, Economics, Law and experience in Scheduled Areas and Scheduled Tribes affairs, Parliamentary Affairs, Constitutional matters related to the Scheduled Tribes; and

(ii) One year's experience in enforcement of regulatory laws or investigation of socio-economic offences, atrocities on tribals and collection of intelligence thereto in a Government/semi-Government Department/organisation or Constitutional/Statutory/Regulatory Body.

Note:

- (i) The period of deputation including short term contract in another ex-cadre post held immediately preceding this appointment in the same or some other Organisation/ Department of the Central Government shall not exceed (03) three years.
 - (ii) The maximum age limit for appointment by transfer on deputation shall be not exceeding 56 years as on the closing date of receipt of application.
- 3. - (ii) Vigilance Clearance Certificate, No Penalty Certificate and Integrity Certificate.
- (iii) NOC/Cadre Clearance
- 4. Applications not received in the prescribed format or received after the last date or without APARs and other relevant documents or found incomplete will not be considered. Candidates may send advance copy of their completed applications. However, at the time of selection, only those applications forwarded through proper channel and are complete in all respects will be considered. Officers, once selected, will not be allowed to withdraw their candidature subsequently.
- 5. The appointment will be on deputation basis. The period of deputation is initially for three (3) years. The terms and conditions of the deputation will be governed as per the instructions issued by Department of Personnel & Training vide O.M. No. 6/8/2009-Estt. (Pay-II) dated 17th June, 2010, as amended from time to time.

- 6. These vacancies were circulated vide circular of even number dated 17.02.2023 (available in Commission's website). The candidates whose applications have been received through proper channel in response to the vacancy circular dated 17.02.2023 need not apply again.
- 7. The essential and desirable qualifications/ conditions are relaxable with the approval of the Hon'ble Chairperson in case of deserving candidates.
- 8. The National Commission for Scheduled Tribes reserves the right to cancel the advertisement/vacancy circular at any time without assigning any reasons.
