With reference to the letter of Research Officer, National Commission for Scheduled Tribes, New Delhi vide reference cited, it is to inform that the Sub-Divisional Police Officer, Wyra got enquired on the representation of Smt. B. Vijaya W/o Badhru, 24 years, ST (Lambada), Cooli R/o Mallupalli (V), Konijerla (M), Khammam Dist. in Cr.No. 147/06 u/s 376 IPC and 3(i)(xii) 3(2) (v) SC/ST POA Act 1989 of Konijerla PS and submit his report as below.

On 17-12-2006 at 2245 hours, the complainant/victim Bhukya Vijaya W/o Badhru, years, of Mallupalli Village along with her husband and others came to P.S. Konijerla and lodged a Telugu written petition stating that, she went to attend coolie work in cotton filed of Rayala Pullaiah to pick-up cotton as usual. On 17-12-2006 morning at about 0800 hours, while she was picking cotton in the filed, at about 0930 hours Gurram Suresh S/o Rangaiah, 28 years, Kamma by caste, Agriculturist of the same village who noticed the loneliness of the complainan came to her and caught hold of hands and forced to full-fill his sexual Lusk and she raised hue and cries. He shut her mouth by using aid of force and pushed her to ground and while ravishing he one Rayala Kalavathi came into the cotton filed and on seeing her, Gurram Suresh stood up and flee away.

The victim narrated the matter to Kalavathi who took her to house where she narrated the rape moident to Rayala Pullaish and also to Bodavath Ramu who are present there. The victim and her bushand have approached Meda Krishnariuna Rao and got drafted a report, stating so, she requested for taking necessary action.

On receipt of the petition from the victim the SHO, ASI/235 of PS Konijerla, was registered a case in Cr. No. 147/2036 Un 376 IPC Sec.3 (i) (xii). 3 (i) (v) of SC/ST POA Act. 1989 and issued express PIR copies to all the concerned officers and referred the victim to Clovi. Hospital. Elizanomam for Medical examination.

On toucht of the Express FIP and on the permission of Superatendent of Police, Elemana on detect 13-12-2006, the SDPO Wyra took up the investigation. SDPO, Wyra, visited the scene of offence and drafted crime detail form in presence of (?) mediators. He recorded statements of victim and certain witnesses in Part-II CDa. The accused was arrested on 27-12-2006 at 1030 hours and during the course of interrogation he admitted his guilt and he was remanded to indicial custody on the same day. The Medical and FSL reports have been received and the case was charged on 05-03-2007 vide SC No.136/2007. The case was acquitted on 24-42-2009 by the Hon ble Addl. District Judge, Court, Khemman. On 12-03-2010 the C.A. is filled in the Hon ble Court for isoming of judgment copy which is avaited. In this case an amount Rs.25, 000/- was paid through chaque as componention to the victim by the M.R.O. Konjierla in the month of August, 2009. He recorded the statement of victim Blinkya Vijava and the same is enclosed herewith for favour of information.
