Kind attention is invited to the subject and
reference cited above. I am herewith submitting the
Enquiry Report for the petition from General Convener
People Protection Forum, Karani, Wayanad district.

The brief of the petition is that the Principal of
Co-operative Training Centre, Karani for SC/ST students,
committed sexual harrasment of one of the student residing
in nearby Girls hostel, while he was working on a Sunday, in his office
and the other inmates in the Girls hostel went to outdoor
picnic with the hostel Warden in the same day.

The Dy Supdt of Police, SMS conducted a detailed
enquiry on this petition and submitted the report. The
report revealed that Sri.A.N.Pradeep Raj, the Principal
of Co-Operative Training Centre, Karani was presented in
his office on 16.3.08 Sunday for completing some pending
works in the office. He stated that he did not call any
student from Girls hostel and never happened such incidents
as alleged in the above said petition and that no students
were taken to outdoor picnic with Warden in the same day.
