With reference to the subject supra, I am here with submitting further report on remarks made by the officers, which are alleged to have been contrary to the allegations made by the petitioner of Sri Vattam Narayana Dora, President of "Adivasi Hakkula Poratam Samithi Thudum Debba" AP, Hyderabad. Details are as:

1). Contradiction over who first saw the body of the deceased:

On enquiry it is noticed that the deceased is the tenant of Ravvala Upendhar S/o Ramulu (**Mother - Ravvala Laxmi Bank Sweeper**). There is common entry door with Varandah to that House, and the deceased is alone is residing in a single room with simple luggage ie a suitcase & bag and a folding cot. The deceased was not locked room door and it is free to move all the inmates. The deceased is taking food from the house owner on payment basis at the rate of Rs.30/- for a day as there were no hotels and it is small village. The deceased and R.Upendhar are use to move closely, and they use go for nature calls at the outskirts of the village. On the early hours on the day of incident R.Upendhar woke up and noticed that the deceased not in the room, and he had seen at the Bank which at distance of 100 Feet and is visible from the said house, as it is located besides the Bank premises. He noticed that the main door is found with out lock. As such R.Upendhar went to the Andhra Bank and found deceased hanging to a ceiling Fan in the front room of the Bank, and intimated to the neighbours.

Further it is to submit that the Bank Sweeper R. Laxmi W/o Ramulu is having three daughter and only one Son namely R.Upendhar, not Ramakrishna. The content of the petitioner that Mr.Ramakrishna has seen the deceased is not correct, and the contents mentioned in paper clipping date 12-10-2005 of Ennadu edition is also not correct.

The Local Police has obtained written complaint from R.Upendhar (House Owner) as the wife & children are at Nelluru-District, and the younger brothers are residing at one is at Paloncha, and another is at Kunavaram of Khammam -District. The Local Police shifted the dead body to the Headquarters Hospital, Khammam before arriving the blood relatives and wife & children to the scene of offence (Beerole-V) Etc.

2). Harassment by superiors under the influence of the deceased predecessor:

The content of the petitioner is not correct and baseless. There is no oral or documentary evidence with regard to harassment by the superior officer under the influence of the predecessor Sri B.S.V.Prasad Branch Manager. Sri B.S.V.Prasad has worked as Branch Manager at Beerole (V) from Feb.2003 to May-2005 and he transferred to Kazipet Branch of Warnagal District. The deceased has got promotion from Junior Management Grade -I to Middle Management Grade-II and posted to Beerole (V). On examination of blood relatives of the deceased, they never disclosed that the superior

3). Hidden hand of the Zonal Authority to humiliate a tribal a tribal employee for the sake of their member:


During the enquiry, I have visited the Zonal Office, Andhra Bank at Hanmakonda, Warngal District and verified the personal file (Service Record) pertaining to the deceased Sri Sode Veera Babu. On perusal of the said file and found that no such memo's are any charge sheets has been issued by the Zonal office, Hanmakonda to the deceased. During enquiry it is noticed that during that period i.e from May-2005 to Oct-2005 Sri R. Appadu (Asst.General Manager) now working at Vijayawada; Sri P.Sriramaraju Asst.General Manager) now working at Vishakapatnam, and Sri P.Srinivas (Zonal Officer) now working as General Manager at Hyderabad are the superior officers to the deceased. I have recorded the written statement of the Zonal Officer Sri M.V.Kameswara Sarma, Hanmmakonda, and copy of the same is here with enclosed for kind perusal.

As such, it is submitted that the content of the petitioner is baseless and on one is coming forward to speak in favour to the contents of the petition. Further I have also made discreet enquiries about the deceased, and noticed no complaints against him. Sri B.S.V.Prasad Branch Manager of Beerole (V) was also resided alone in the same house (single Room) keeping his family members at Hyderabad. Sri B.S.V.Prasad Branch Manager also use to taking food from the House Owner on payment basis during entire period i.e. from Feb.2003 to May-2005. Further it is to submit the petitioner is not traced and when contacted to the Phone numbers noted in his letter pad are no in use. It is noticed that he is a "Phyравicar" by submitting the representations to the higher ups to gain sympathy from their caste people". There is no eyewitnesses or any documentary evidence in the suicidal death of the deceased. Except on the circumstantial evidence it presuming that the deceased has felt mental tension with the Bank workload at Beerole (V) and he is unable to manage the local people and political leaders pressure, taking decision on sanctioning of Bank Loans Etc.

The Statements of R.Upendar (House Owner), B.V.S.Prasad and the present Zonal Officer Sri M.V.,K.Sharma is enclosed for kind perusal and information.
