Islavath Neelamma W/o Shanker Caste Lambada R/o Humla Naik Thanda H/o Talakondapally (v) and Mandal was gang raped by other caste people by name 1. Bashamoni Yadaiah S/o Jangaiah 2. Gundemoni Sudhaker S/o Anjaiah 3. Perumalla Ramesh S/o Vandanaiah all R/o Talakondapally on 12.7.2006.


A case in Cr.No.20/2006 dt: 16.7.2006 u/s 376 IPC and Section 3 (1) XI (2) V of SC/STs (POA) Act 1989 at PS Talakondapally has been registered.

An amount of Rs. 25,000/- Rupees Twenly five thousand only) being 50% of the exgratia has been sanctioned vide reference 4<sup>th</sup> cited and paid to the victim vide D.D. No.584051 dt: 25.11.2006.

The R.D.O., Mahabubnagar has been requested to provide house site plot, Pucca house and Govtl land to the victim as a mesure of rehabilitation.

The case of the victim for providing employment or pension of Rs. 1000/- per month is under examination and will be considered subject to eligibility.
