
Apropos the letter under reference, this is to submit that the contents of the complaint against the alleged sexual harassment of Smt.S.K.Barua, Messenger, Dredging Corporation of India Ltd. by one Sri.P.V.Krishna Rao Asst., Finance Department, Dredging Corporation of India Ltd., Visakhapatnam, have been enquired into by the Asst. Commissioner of Police, North, Visakhapatnam City.

During the course of inquiry it is revealed that Smt.S.K.Barua, who is working as a Messenger, in DCI, Visakhapatnam, had lodged a complaint with the management of DCI, against the harassment by Sri.P.V.Krishna Rao, who is working as Assistant in finance department, DCI. No complaint was lodged with police in the matter. The departmental authorities conducted an enquiry and transferred the alleged respondent, P.V.Krishna Rao, from finance department to establishment wing. During the enquiry conducted by the Commissioner of Police, North, Visakhapatnam, it is revealed that there was a simple dispute between the complainant and the alleged respondent, as he scolded her, as a part of their routine job, but not with any intention to insult her. It is also revealed that the alleged respondent never abused her by mentioning her caste, etc.

When the Asst. Commissioner of Police, North, Visakhapatnam, personally enquired with the complaint, she informed that there are no disputes among them at present.

Hence, no further action is warranted in the matter. The reference received with the reference cited is resubmitted herewith.
