Subject: Regarding complaint of Sh. Chalitra Lohara. (Rawindra Nathy)

Sir,

Kindly refer to NHRC Case No. 625/30/8/09-10/UC/M-5 dated 12.5.09, on the subject cited above.

The complainant has alleged that he is a member of Scheduled Tribe Community and residing at D-91, East of Kailash. The complainant and his family members have been experiencing racial discrimination at the hands of his neighbour Mr. B.K. Kapoor (alleged person) and he had advised to sell the said property and go to some other place. On 20.4.09, he hatched a conspiracy in connivance with officials of PS Amar Colony to humiliate and force them to leave the place. The complainant stated that Mr. Kapoors trying to convince other residents that the complainant and his family had committed crimes and their existence is dangerous for other residents. He further stated that police officials of PS Amar Colony misbehaved and arrested his wife and son. The complainant stated that his son was physically tortured at the Police Station and he had sign two papers alleging that his family is being harassed because they belong to ST Community.

Enquiries were conducted into the matter which revealed that on 19.4.09 Mr. B.K. Kapoor has lodged a complaint in PS Amar Colony wherein he had alleged that on 18.4.09 at about 5.30 AM, he found envelope in which extortion has demanded for Rs. 10 lacs and the extortion amount was to be placed in bag on motorcycle parked outside D-91, East of Kailash, New Delhi (residence of the complainant) on 20.4.09 till 2 PM. The letter was typed and signed as 'Dawood' in Hindi and 'D' Company in English. On this complaint, SI Pramod Gupta constituted a raiding party. Sh. B.K. Kapoor prepared a dummy bag and plac 1 it in the said

place. Sh. Shashi Bhushan (complainant's son) reached there in a motorcycle. After some time, Smt. Punia Devi w/o Chafitra Lohara (present complainant) came and walked around the motorcycle in a suspicious manner and picked the bag. She was apprehended by the police and a case was registered vide FIR No. 203/09 dated 20.4.09 u/s 384/385/387/34 IPC PS Amar Colony and investigations was taken up. During investigations, she was arrested and disclosed that her son Shashi Bhushan had told her to carry the bag. On the statement of Punia Devi, her son Shashi Bhushan was also arrested. He was also arrested in case FIR No. 1228/07 u/s 420 IPC PS Malviya Nagar. Now he is on bail. The allegations levelled against the alleged person and police are baseless and could not be substantiated.
