**TOUR REPORT FOR THE PERIOD FROM
21-6-2012 TO 27-6-2012**

I started my tour to Udaipur, and other places of Rajasthan on 21.6.2012. On 22.6.2012, I held meeting with District Collector, Udaipur and officers of Forest Department and discussed community Right Under Section 3 and Section 5 of the Forest Act 2006.

I was specially deputed by the Hon'ble Chairman to make on the spot enquiry on the complaint to the Commission by villagers of Salumber and Lasaria Block of District, Udaipur about violation of Community Right under Forest Act 2006 and PESA Act 1996. The representatives of villagers of Slambur also attended the meeting held with District Collector at 11.30 AM on 22.6.2012. The issues were discussed at length and it was assured by District Collector to get the entire matter examined and various grievances highlighted by the villagers in their complaint shall be resolved to the entire satisfaction of the commission. The District Collector sought one month time to submit his detailed report thereon. Similiaraly the issues regarding the Jadola Block Panchayat Jakara were also discussed. The District Collector will submitted his detailed report thereon within one month as assured by him.

The District Collector, Udaipur submitted the dully filled in Questionare vide his covering letter reference No F-38(2)/Gen/ST/2011-12/2154 dated 18//6/12. The copy of the same is enclosed herewith as **Annexure A**.

On 23.6.2012 I held meeting with Tribal Delegates at Udaipur. Various issues regarding Tribal Development were discussed. It was brought to my notice by the delegates about slow progress of construction of roads leading to some of the Tribal Areas. The problems of searecity the water in the Tribal Area was also

On 25.6.2012 I visited district Pratapgarh where I held meeting with the District Collector Pratapgarh. Various issues regarding Tribal Development were discussed . A copy of the report was also submitted by the District Education Officer Primary Education, Pratapgarh and the same is enclosed as **Annexure D**. Simualarly a copy of report was submitted by the office of Chief Medical Officer, Pratapgarh was submitted and same is enclosed as **Annexure E**. Report of Electricity Production and Distribution submitted by the office of Supdt. Engineer, Pratapgarh was also submitted during the meeting and the same is enclosed as **Annexure F**. The copy of report on **Mahatama Gandhi National Rural Employment Gruntee Act**. In respect of District Pratapgarh, Rajasthan, submitted by the District Collector, Pratapgarh is enclosed as **Annexure G**. I appreciated the work done by the District Administration during my meeting with District Collector, Pratapgarh

On completion of my tour I came back to Delhi on 27-6-2012. The report is submitted for your kind perusal and necessary action.
