2004-05 & 2005-06-Printing of the Report for laying in Parliament.

Sir,

I am to invite your attention to this Commission's letter of even number dated 24.11.2008 on the above subject and to say that the reply of the Ministry is still awaited.

2. As per Article 338A (6) of the Constitution, the Report of the Commission is to be laid before each House of Parliament alongwith a memorandum explaining the action taken or proposed to be taken on the recommendations relating to the Union and the reasons for the non-acceptance, if any, of any of such recommendations. It is hoped that the Ministry might be in the process of laying the Report alongwith a memorandum explaining the action taken or proposed to be taken on the recommendations relating to the Union in both Houses of Parliament.

3. As the Report is required to be laid in English as well as Hindi, the Ministry was requested to indicate whether printing of the Report in both the languages will be undertaken by the Ministry. It was mentioned that in the event, the printing of the report has to be undertaken by the Ministry, Camera ready copies of the Report in English as well as Hindi version of the Report will be furnished to the Ministry of Tribal Affairs for necessary action and in case the Report is to be got printed by the National Commission for Scheduled Tribes, the number of copies of the Report in English and Hindi each required by the Ministry for laying in both Houses of the Parliament and for internal consumption of the Ministry may please be intimated well in advance. Non-receipt of this information is likely to delay the printing of the report. It is also not proper and safe to store the printed copies of the Report in advance, as the Report is treated as confidential till it is laid in the Parliament.

4. If the Report is to be got printed by National Commission for Scheduled Tribes, it is requested that the number of copies of the Report in English and Hindi each required by the Ministry for laying in both Houses of the Parliament and for internal consumption of the Ministry may please be intimated at least three months prior to the date of laying the Report in Parliament as the printing of the Report requires sufficient time. A reply in the matter is solicited urgently.

Sir,

A copy of the first Report of the National Commission for Scheduled Tribes for the period 2004-05 & 2005-06 was submitted to the Ministry of Tribal Affairs soon after it was presented to the Hon'ble President of India on 08.08.2006. As per Article 338A (6) of the Constitution, the Report of the Commission is to be laid in both Houses of Parliament, alongwith Memorandum explaining the action taken on the recommendations contained in the Report relating to the Union. It is hoped that the Ministry might be in the process of laying the Report in both Houses of Parliament. As the Report is required to be laid in English as well as Hindi, the Ministry may kindly indicate whether printing of the Report in both the languages will be undertaken by the Ministry and, if so, the Hindi version of the first Report will be furnished to the Ministry of Tribal Affairs for necessary action. In case the Report is to be got printed by National Commission for Scheduled Tribes, the number of copies of the Report in English and Hindi each required by the Ministry for laying in both Houses of the Parliament and for internal consumption of the Ministry may please be intimated at least two months prior to the date of laying the Report in Parliament. It may be mentioned that the printing of the Report requires sufficient time, but on the other hand it is also not proper and safe to store the printed copies of the Report in advance, as the Report is treated as confidential till it is laid in the Parliament. A reply in the matter is solicited urgently.
