Whereas the National Commission for Scheduled Tribes (NCST) vide letter of even number dated 03.10.2017 has sought the comments/action taken report on the points raised in the representation dated 17.09.2017 of Shri Rajiv Ranjan within 30 days from the receipt of the notice. Response was not received from the Govt. of Maharashtra. In this context, a team headed by Smt. Maya Chintamn Ivate, Hon'ble Member, NCST visited State of Maharashtra from 21.11.2017 to 24.11.2017 for spot enquiry, a visit report of the team of the Commission is enclosed.

In this regard, it is stated that Shri Nand Kumar Sai, Hon'ble Chairperson, National Commission for Scheduled Tribes has decided to discuss the matter with you on **28.12.2017 at 12.00 Noon**, 6th Floor, 'B' Wing, Lok Nayak Bhawan, Khan Market, New Delhi-110003 for investigation/inquiry/ action to be taken in the matter in pursuance of the powers conferred upon it under Article 338A of the Constitution of India.

3. You are requested to kindly make it convenient to attend the Sitting in Commission in person on the scheduled date and time and submit the facts and action taken on the matter.

4. Further, it is requested to bring all the relevant records/files in the matter for placing before the Commission as would be necessary during the Sitting.

5. Please take notice that in case of failure to attend the Sitting, the Commission will be constrained to exercise the powers of civil court conferred upon it under Clause (8) of Article 338A of the Constitution of India and issue summons for the appearance in person before the Commission.
