

Sub: Minutes of the Proceedings of the Sitting held under the Chairmanship of Shri Ravi Thakur, Hon'ble Vice Chairperson, National Commission for Scheduled Tribes, Government of India, New Delhi to discuss the petition submitted by Shri Makhan Lal Meena, Teacher, (TGT) Govt Lady Noyce Senior Secondary School for Deaf, Government of National Capital Territory of Delhi for revising the Recruitment Rules for the post of Head Master and his promotion thereto on 20-11-2015 at 11.00AM in the Commission.

Shri Makhan Lal Meena, Teacher (TGT), Govt Lady Noyce Senior Secondary School for Deaf, Government of National Capital Territory of Delhi vide his application dated 26-12-2014 has submitted to the Commission that the Recruitment Rules (RRs) for filling up of the post of Head Masters in the Schools meant for Deaf under the Social Welfare Department of Government of Delhi has not been revised since 1971. Promotions to the post of Head Master are done based on the present RRs and there are lacunae's as far as educational qualifications are concerned.

2. A sitting was held on 3-4-2014 under the Chairmanship of Shri Bheru Lal Meena, former Hon'ble Member of this Commission in which Shri P. C. Sharma, Joint Director and Shri Kuldeep Singh, Deputy Director attended the sitting. Another sitting was chaired by Shri Ravi Thakur, Hon'ble Vice Chairperson on 23-6-2014 at 15.30 hrs in which Smt. Saroj Rawat, Joint Director and Shri S. M. Ali, Superintendent attended the sitting. It was submitted by the Joint Director of Government of National Capital Territory of Delhi that the Recruitment Rules for the post of Head Master in the special schools under Delhi Government is under revision and the promotions will be done as per the existing RRs till the RRs are revised.

3. Not convinced with the actions taken by the Social Welfare Department of Government of Delhi, Shri Makhan Lal Meena has again represented to the Commission vide his representation dated 15-9-2015 and accordingly a sitting in this case was arranged on 20-11-2015 at 11.00AM. Ms. Gitanjali Gupta, Secretary, Social Welfare, Government of National Capital Territory of Delhi authorized Ms. Dilraj Kaur, Director, Social Welfare to attend the hearing in the Commission vide authority letter dated 18-11-2015. Accordingly, Ms. Dilraj Kaur, Director attended the hearing alongwith Shri A. K. Mishra, Additional Director and Shri R.S. Rana, Deputy Director. The applicant Shri Makhan Lal Meena, TGT also attended the hearing.

4. The case was explained before the Commission. Officers attended the sitting informed that they are all new in the Department and the case has not come before them for examination and they will examine the case with reference to his representation. Necessary action will be taken to revise the RRs for the post of Head Master in the Special Schools under the Social Welfare Department of Government of National Capital Territory of Delhi. The officers stated that the RRs will be revised within a couple of months and in the meantime action to promote Shri Makhan Lal Meena will be initiated by holding Departmental Promotion Committee for the post of Head Master and the same shall be reported to the Commission on or before 1-2-2016.

The meeting ended with a vote of thanks to the Chair.
