Two representations dated 29.08.2017 received in this Commission on 19.09.2017 & 20.09.2017 from Shri Suna Ram Soren, MTS L-Division, CPWD, New Delhi and Shri Mohan Lal, MTS, CPWD, C-256, Sub-Division-3, L, Minto Road, New Delhi regarding promotion on the basis of Limited Departmental Examination for year 2012.

2. The matter was taken up with the Director General of CPWD, New Delhi vide this Commission's letter of even number dated 16.11.2017. No reply/comments have been received in the Commission from the CPWD. However, an email was received from CPWD on 29.03.2018.


3. In this case, Sittings were held on 27/12/2017 and 05/01/2018. However, so far no progress was made in the matter and petitioners have been approaching the Commission on regular basis. Therefore, summons were issued to the Secretary, Urban Development and DG, CPWD for a Sitting on 11/05/2018. However, the Secretary, Urban Development did not attend the Sitting.

Gist of discussion/advice

Hon'ble Chairperson took serious view that inspite of holding a number of Sittings in the matter, DG, CPWD and Ministry of Urban Development did not heed the advice of the Commission. The petitioners informed in the Sitting that SC candidates selected in said departmental examination had been promoted after making one-time relaxation as per the advise of National Commission of Scheduled Castes and, therefore, they requested for similar one-time relaxation in their case and they also should be promoted.

Hon'ble Chairperson stated that if relaxation can be given to SC candidates, why not similar relaxation can not be given to ST candidates.

After detailed discussion in the matter, Hon'ble Chairperson advised Ministry of Urban Development and DG, CPWD to take necessary action to promote remaining 19 ST candidates who were selected in the departmental exam conducted for Group D employees for promotion to LDC. The Commission desired that action in this effect should be completed within 15 days from receipt of the Commission's recommendation. In response to this, officials from Ministry of Urban Development and DG, CPWD assured the Commission that they will take necessary action in this regard immediately.
