SITTING NOTICE

Sub: Representation dated 27.10.2018 received from Shri Anduru Gopal, Joint Sub Registrar, Markapuram, Prakasam District, Andhra Pradesh regarding complaint against Shri B. Suryanarayana, Deputy Inspector of Registration & Stamps, Kakinada for harassment and discrimination of ST officer.

Whereas the National Commission for Scheduled Tribes (NCST), as per the Constitutional mandate and as per powers conferred upon it under Article 338 A of the Constitution of India has decided to investigate into the aforementioned matter. The requisite report in the case sought under NCST notice of even number dated 14.11.2018 is still awaited despite passing of stipulated periods.

2. Smt. Maya Chintamani Innate, Hon'ble Member, National Commission for Scheduled Tribes has again fixed a Sitting in the Commission at New Delhi on 29.01.2019 at 02.00 P.M for investigation/inquiry/ action to be taken in the matter.

The petitioner may also be advised to be present on the day of Sitting in the Commission.

4. Please take notice that in case you fail to attend the sitting, the Commission is at liberty to exercise the powers of Civil Court under Clause (8) of Article 338A of the Constitution of India for enforcing your attendance before the Commission.
