SITTING NOTICE

- Sub: Representation dated 01.08.2018 received from Dr. Koduri Narayana Rao, Chamallamudi, Via Etkukur, Guntur (Andhra Pradesh) regarding denial of Land Pattas to poor people belongs to ST community of Challamudi Village, Varricherukuru Mandal, District- Guntur (AP).

Whereas the National Commission for Scheduled Tribes (NCST), as per the Constitutional mandate and as per powers conferred upon it under Article 338 A of the Constitution of India has decided to investigate into the aforementioned matter. The requisite report in the case sought under NCST notice of even number dated 26.10.2018 is still awaited despite passing of stipulated periods.

2. Smt. Maya Chintamn Ivnate, Hon'ble Member, National Commission for Scheduled Tribes has re-scheduled the Sitting to be held on 30.01.2019 and has now refixed the Sitting for **13.02.2019 at 02.00 P.M** in the Commission at New Delhi for investigation/inquiry/ action to be taken in the matter.
3. Accordingly, you are requested to appear in person for examination before the Hon'ble Member on the above scheduled date and time along with action taken report, full facts and all relevant original records/documents pertaining to this case. The petitioner may also be advised to be present on the day of Sitting in the Commission.
4. Please take notice that in case you fail to attend the sitting, the Commission is at liberty to exercise the powers of Civil Court under Clause (8) of Article 338A of the Constitution of India for enforcing your attendance before the Commission.
