
Minutes of sitting held in the NCST's Headquarters on 16/07/2019 under the Chairmanship of Miss Anusuiya Uikey, Hon'ble Vice- Chairperson, NCST in the case of Smt Karma Dolma, Lect. in Social Science, DIET Jarad, Tehsil- Bhuntar, District- Kullu, (Himachal Pradesh) regarding harassment by in-charge Principal Govt. Sr. Sec. School (B) Kullu.

List of participants is annexed.

Smt. Karma.Dolma, Lect. in Social Science, DIET Jarad, Tehsil- Bhuntar, District- Kullu, (Himachal Pradesh) vide representation dated 01.03.2019 has stated that the Department of Higher Education, Govt. of Himachal Pradesh harassing by transfer on secondment as she is going to retire on 31.05.2019 and requested for justice. The National Commission for Scheduled Tribes (NCST) took up the matter with Additional Chief Secretary, Department of Education, Govt. of Himachal Pradesh for facts and comments on 18.03.2019. The Department of Higher Education, Govt. of Himachal Pradesh vide letter dated 05.04.2019 has referred the matter to Director of Higher Education, Govt. of Himachal Pradesh, Shimla for inquiry and submit the report within 3 days, an endorsement to NCST. The NCST vide letter dated 22.04.2019 had sought the facts and comments from Additional Chief Secretary, Department of Education and Director of Higher Education, Govt. of Himachal Pradesh, Shimla. The reply was not received. The petitioner visited this Commission on 08.05.2019 and stated that she will be retire on 31.05.2019 and the Department has not taken any action for pension and requested for justice.


The Hon'ble Vice-Chairperson fixed the sitting on 16.07.2019 to discuss the matter with the Addl. Chief Secretary, Department of Higher Education, Director, Higher Education, Govt. of Himachal Pradesh, Shimla and the petitioner.

In the sitting, the Hon'ble VC asked to petitioner to explain the grievances and problems. The petitioner stated that the Department of Education had not paid the salary for the period from 1st May 2018 to October, 2018 and the pension papers has not been prepared by the Department so far. The Hon'ble VC asked the representative (s) of the Higher Education Department, Govt. of Himachal Pradesh to explain in the matter.

The representative (s) stated that all recommendation of the commission implemented. Action has been taken against accused and negative comments also marked in his service book. The representative (s) also assured that all other grievances will resolve as soon as possible.

After detailed discussions, with the representative (s) of Department of Higher Education and the petitioner, the Hon'ble VC recommended that the Department of Higher Education, Govt. of Himachal Pradesh and Directorate of Higher Education should redress the issue related to retirement benefits and submit the report to the Commission within 15 days from the receipt of the proceedings.
