Minutes of sitting held on 27/09/2019 at 2:00 P.M. under the chairmanship of Dr. Nand Kumar Sai, Hon'ble Chairperson, NCST in the representation of Shri Milind V. Awad, General Secretary, All India SCs & STs Railway Employees Association, Central Railway Zone (Zonal Executive Committee) CSMT, Mumbai regarding corruption in Central Executive Committee, All India SCs & STs Railway Employees Association.

2. Shri Milind V. Awad, General Secretary, All India SCs & STs Railway Employees Association, Central Railway Zone (Zonal Executive Committee) CSMT, Mumbai vide representation dated 27/03/2019 has alleged that the corruption in Central Executive Committee of All India SCs & STs Railway Employees Association, New Delhi. The NCST referred the matter to Chairman, Railway Board and Registrar of Societies, New Delhi on 22/04/2019 for facts and comments.

3. The Railway Board vide letter No. 2019-E(SCT)I/22/6 dated 14/05/2019 had furnished the facts and comments and informed that there were Court Cases between the Associations (the petitioner Association and Central Executive Committee, All India SCs and STs Railway Employees Association headed by Shri B. L. Bairwa as President).

4. The issue was discussed in the sitting held on 11/06/2019 at NCST, Loknaya Bhawan, New Delhi under the chairmanship of Hon'ble Chairperson, NCST with the representative of Railway Board, Registrar Societies and the Office bearer of All India SCs and STs Railway Employees Association, Central Railway Zone (Zonal Executive Committee), Mumbai. After detailed discussions, Commission decided that a sitting will be convened with the opponent i.e. President or General Secretary of Central Executive Committee, All India SCs and STs Railways Employees Association for discussion to find out the facts.

5. In pursuance of decision taken in the sitting dated 11/06/2019, the Hon'ble Chairperson, NCST fixed the sitting for 27/09/2019 to discuss the issue with the Chairman, Railway Board, Registrar of Societies, New Delhi, Office bearer of Central Executive Committee, All India SCs and STs Railway Employees Association and Office bearer of All India SCs and STs Railway Employees Association, Central Railway Zone (Zonal Executive Committee) Mumbai. The notice was issued on 19/09/2019.

6. In the sitting dated 27/09/2019, on behalf of Railway Board, Executive Director (E), Reservation and Joint Director Estt. (Res.) and on behalf of Registrar of Societies, New Delhi Naib Tehsildar appeared in the sitting. The Office bearers of Central Executive Committee, All India SCs and STs Employees Association and petitioner (Shri Milind V Awad and other Office bearers) were appeared before the Commission.

7. The Hon'ble Chairperson decided to hear the background of the case by Shri B. L. Bairwa, President and other Office bearers of the Central Executive Committee, All India SCs and STs Railway Employees Association. Shri Bairwa explained background and stated that the matter is pending before the Ld. Patiala House Court against the petitioner (Shri Milind V Awad).

8. The Hon'ble Chairperson asked the representative of Registrar Societies to explain the facts and role of Registrar of Societies in the matter. The representative of Registrar Societies, New Delhi has not issued certified list of latest elected Members of Association. The Registrar of Societies is empowered to certify the Office bearers of the Association. The other functions and duties of the Association rests with the elected Office bearers of the concerned Association.

9. The representative of Railway Board informed that the role of Railway Board is very limited in this matter. The Railway Board only circulates the list of elected Office bearers of the Association among the all Departments of Railways. In the case, the elected list of Office bearers have been circulated by the Railway Board vide letter No. 2018-E(SCT)/I/22/12 dated 30/10/2018 for the period of 2018-2021.

10. The Commission observed that the matter raised by the petitioner (Shri Milind V Awad) relates with the genuineness of the All India SCs and STs Employees Association. This is to be dealt with by Registrar of Societies, who empowered to certify the list of elected Office bearers of concerned Association. The purpose of the Associations for the welfare of Scheduled Tribes Employees.

11. After detailed discussions with the representative of Railway Board, Registrar of Societies, New Delhi and the Office bearers of Central Executive Committee, All India SCs and STs Railway Employees Association, New Delhi, the Commission suggested that the list of elected representative of Association to be got it certified from the Registrar of Societies, New Delhi. It was also decided that there is no need to take up the matter further. Hence, this case may be closed.
