- The Management of Chennai Port Trust, Chennai will consider the case of promotion of Shri P. Kathiresan fairly and without discrimination, as and when vacancy arises for the post of Superintendent Engineer in the Mechanical Department.
- The Chairman, Chennai Port Trust, Chennai informed that the Chairman (Chairman, Chennai Port Trust) is the appellate disciplinary authority and he will examine the case (Vigilance Department) for the construction and improvement to the property of Shri P. Kathiresan sympathetically.
