Minutes of sitting held in the NCST's Headquarters on 08/10/2021 at 11:00 AM under the Chairmanship of Shri Ananta Nayak, Hon'ble Member, National Commission for Scheduled Tribes in the case of Shri Pratap Kerketta, (At-Mandnabahal, P.O.-Subdega, District-Sundargarh, Development Officer (terminated), LIC.

List of participants is annexed.

Shri Pratap Kerketta, Development officer (terminated) LIC of India, Uditnagar Branch, DO Sambalpur (Odisha) (At-Mandnabahal, P.O.-Subdega, District-Sundargarh) vide representation dated 28.07.2016 has requested regarding reinstatement in LIC of India. The matter was taken up with the Chairman, LIC of India for facts and comments. The LIC of India has furnished the facts and comments, which was communicated to Shri Pratap Kerketta for satisfaction. Shri Pratap Kerketta refuted the facts and requested for justice.

Shri Ananta Nayak Hon'ble Member, National Commission for Scheduled Tribes has decided to discuss the issue with the Chairman, LIC of India and Shri Pratap Kerketta on 08.10.2021 at 11:00 AM. The officers from LIC of India and petitioner, Shri Pratap Kerkatta were present in the sitting.

The officers of LIC of India reiterated LIC's comments submitted to the NCST and stated that as per rules, the LIC is not a position to reinstate the petitioner in the service of LIC of India.

After detailed discussions with the officers of LIC and petitioner, the Hon'ble Member suggested that keeping in view of the economic condition of the petitioner, LIC may consider his appointment as Chief Life Insurance Agents (CLIA) in the nearby branch of LIC.

An Action Taken Report on the aforesaid recommendations may be submitted to the Commission within 30 days.
