Minutes of the Sitting held on 14.12.2021 at 3:00 P.M. under the Chairmanship of Shri Ananta Nayak, Hon'ble Member, NCST, New Delhi in the case of Shri Mahesh Kumar Meena, S/o Shri Tunda Ram Meena (Rajasthan) regarding non-implementation of reservation in recruitment and rejection of his candidature by Sports Authority of India (SAI).

Representation dated 10.02.2020 from Shri Mahesh Kumar Meena, S/o Shri Tunda Ram Meena regarding non-implementation of reservation in recruitment and rejection of his candidature by Sports Authority of India (SAI).

A Sitting was scheduled at Commission (HQ). Accordingly, Summons was issued to Director General of Sports Authority of India for personal appearance on 14.12.2021 before Shri Ananta Nayak, Hon'ble Member, National Commission for Scheduled Tribes. The representatives/ officers from Sports Authority of India were appeared and the petitioner was also present.

In the sitting, petitioner informed the Commission that he applied for the post of 'Young Professional' where his candidature was wrongly rejected and there was no reservation system applied in this recruitment process. The representatives/officers of SAI explained that recruitments for the post of 'Young Professional' were purely contractual and were made as per the guidelines of Niti Ayog and there was no reservation prescribed for it. Further, petitioner's candidature was rejected as he failed to furnish requisite documents at the time of interview. The DoPT guidelines for reservation in contractual posts apply to Sanctioned Posts only, hence not applicable in the present case. Respondent also explained the efforts of Authority in recruitment of Scheduled Tribes candidates in various other posts.

After detailed discussion with both the parties, Commission recommended that SAI should extend its monitoring mechanisms through its regional centers for promotion, advertising and selection process in tribal regions for ST candidates, as SAI agrees that the best candidates in the domain of sports can be found in these areas. A report highlighting the efforts/activities of SAI for tribal population be submitted before Commission within 30 days of receipt of these recommendations. The petitioner was advised to submit the advertisement of various agencies in States and central Government regarding engagement of young professional to SAI directly and under intimation to NCST for consideration of his candidature for the engagement of Young Professional in SAI.
