PROCEEDINGS OF SITTING HELD ON 05.01.2022 CHAIRED BY SHRI ANANTA NAYAK, HON'BLE MEMBER NATIONAL COMMISSION FOR SCHEDULED TRIBES (NCST) IN THE CASE OF SHRI NANDLAL, EE, MECHANIC, 505 ARMY BASE WORKSHOP, DELHI CANTT, REGARDING DISCRIMINATION IN PROMOTION TO THE POST OF MCM.

List of officers present in sitting is Annexed.

Shri Nandlal vide his representation to Commission dated 16.06.2020 submitted that he was appointed in 505 Army Base Workshop, Delhi Cantt in the year 1997, after relieving himself from Delhi Police, where he worked as Constable MT from year 1995 to 1997. His grievance is petitioner's period of service in Delhi Police was included only in the year 2016, for the limited purpose of pension and not promotion. The Co-worker's services were included and they were promoted before the Petitioner.

A Notice dated 30.06.2020 was issued to the Ministry of Defence and Director General, EME for facts and comments.

In reply to these allegations, Respondent Authority clarified that Petitioner got promotion in the year 2007 as per policy, where 10 years of service is counted for promotion. Further, the period when Petitioner was working in Delhi Police, was not counted in promotion, as the service at Delhi Police was not a skilled /highly skilled one as mentioned in the Policy.

The reply was objected to by the Petitioner by filing Rejoinder and with subsequent communications between parties, Summons were issued to Director General, EME for Sitting in Commission Headquarters on 05.01.2022 at 03:00 PM, chaired by Shri Ananta Nayak, Hon'ble Member, National Commission for Scheduled Tribes.

The Petitioner reiterated the grievance and submitted that his services at Delhi Police, being a technical one, must be counted for promotion. In reply, the Respondent Authority submitted that the grievance will be duly considered if Petitioner establishes that the service at Delhi Police as Skilled /Highly Skilled as per the Policy.

In light of aforesaid sitting, the written submission filed by Respondent to Commission is forwarded to Petitioner for his reply to Respondent Authority directly, with intimation to Commission.

Once the Petitioner submits his reply, Respondent will decide the issue of his Promotion within 15 days. Thereafter, an action taken report may be submitted to the Commission by Respondent, within one 30 days period.
