1. A representation was received in the Commission from Smt. Tsewang Dolma, LIO, Central Institute of Buddhist Studies, Leh, Ladakh, regarding grant of the 1st ACP in the scale of Rs. 10000-15200 w.e.f. 1999 and the next grade of Rs. 14300-18300 as 2nd ACP w.e.f. 2006, and also for extending the benefit of retirement at the age of 62 years as had been done for teaching staff and as notified by UGC.
2. The matter was taken up with the Secretary, Ministry of Culture vide this Commission's letter dated 19/05/2016, 01/07/2016 and 29/07/2016 wherein it was informed about the Sitting of the Commission on 29/08/2016 at 2:00 P.M.
3. The Sitting was held in the Conference Room of NCST on 29/08/2016, under the Chairmanship of Hon'ble Vice Chairperson, NCST, to discuss the matter.

5. Ministry of Culture vide letter dated 29/08/2016 has requested to exempt Secretary and deputed Joint Secretary in place of Secretary, Ministry of Culture due to DPC in UPSC. Hon'ble Vice Chairperson has allowed the same.



6. During discussion the Hon'ble Vice Chairperson asked the Joint Secretary, Ministry of Culture to explain the position of case.
7. The Joint Secretary has explained the rule position of MACP and also stated that the matter regarding the retirement age of 62 is already under Agenda of Governing Body, and the same will be discussed on 30/08/2016.
8. The Hon'ble Vice Chairperson advised that the Ministry of Culture may take up the matter grant of first ACP with Department of Personnel & Training, Govt. of India, New Delhi immediately and regarding the retirement of Tsewang Dolma she will be allowed to continue as the retirement age has been extended to 62 years for all teaching staff and in the light of UGC guidelines.
9. The Sitting ended with vote of thanks to the Chair.
