#### NATIONAL COMMISSION FOR SCHEDULED TRIBES

PROCEEDINGS OF SITTING HELD ON 10.02.2022 CHAIRED BY SHRI ANANTA NAIK, HON'BLE MEMBER, NATIONAL COMMISSION FOR SCHEDULED TRIBES (NCST) IN THE CASE OF REPRESENTATION OF ATROCITY AGAINST STs AND BURNT, DESTROY OF 40 HUTS OF ST PEOPLE OF CHADARGHAT, HYDERABAD.

The petitioner Shri M. Mallaiah, Hyderabad vide his online representation dated 2.1.2022 has submitted grievances of atrocity against STs and burnt/destroy of 40 huts of ST people belonging to Erukula ST Community of Telangana at Chadarghat, Hyderabad by the non ST persons- action against accused under SCs and STs (Prevention of Atrocity) Act 1989, rehabilitation and providing compensation to the victim ST family.

The case was taken up with the Director General of Police, Telangana Police, Commissioner of Police, Hyderabad City and the District Collector, Ranga Reddy District for a report vide NCST Notice dated 5.1.2022.

In pursuance of the Commission's notice, the Commissioner of Police, Hyderabad City has submitted a report stating that on 31.12.2021, the Afzalgunj Police received a message through Dial-100/VHF stating that there was a fire accident to the huts of petty vendors, Sai Baba Temple, Chadarghat, Hyderabad. The Police officials with fire tenders immediately rushed to the incident place and started rescue operation. During the fire, about 35 huts were damaged. No causalities were happened. The reasons for fire was that one occupant was cooking food on fire wood. Accidently, fire caught to her hut and with the wind it spread to other huts also. A case in crime No. 566/2021 U/H accident was registered and investigated. The Police recorded statements of all victim ST families. During the investigation, it was established that the incident occurred accidently and all household articles and food grains and other valuables were burnt to ashes. There is no foul play. The victim family was also given a compensation of Rs.6000/- which has been accepted by them.

The report was found to be unsatisfactory. A sitting was held on 10.2.2022. In the sitting, the Assistant Commissioner of Police, Hyderabad City and Inspector of Police, Telangana Police, Hyderabad City, on behalf of the Commissioner of Police, Hyderabad city appeared. The petitioner Shri Mallaiah was also present.

In sitting, the petitioner has submitted that there was a plot at Hyderabad City wherein 40 Erukula ST community were residing for last 40-50 years. The ST people were engaged petty handcraft business by erecting their huts. On 31.12.2021, with the intention of vacating of the plot, some local goons and some non ST person have burnt the huts. Due to which, all household articles and other essential commodities

NATIONAL COMMISSION FOR SCHEDULED TRIBES भारत सरकार/Govt. of India were destroyed. No compensation was paid and no rehabilitation by way of construction of huts were made. On other hand, the Revenue officials have threatened to vacate the land. However, the rescue efforts of the Police were appreciable.

The Assistant Commissioner of Police has briefed about the case and further informed that on receipt of the information of fire on the huts on 31.12.2021, the Police took prompt rescue operation and there was no casualty. The incident was happened accidentally due to cooking of food on wood. There was no hand of other people in the incident. The District Administration has also provided an amount of Rs.6000/- as compensation to the victim ST family. He further informed that the land wherein the ST people residing is government land and a notice for vacating the land for beatification of nancy river has already been issued to all concerned. Presentaly, the matter is in Court. Details about rehabilitation will be provided by the District Collector, Hyderabad.

The matter was discussed in detail. The Commission observed that the police took prompt action to tender the fire. There was no casualty. However, the petitioner's allegation of grabbing of land and rehabilitation of ST families will be taken up with the District Authorities.

It is accordingly decided that the petitioner will submit a rejoinder within 30 days to the Commission about the grievances of grabbing of land, threaten to vacating the land and rehabilitation of ST families. A report will then obtain from the District Collector Hyderabad.
