Minutes of sitting held in the NCST's Headquarters on 10/02/2022 at 12:30 PM under the Chairmanship of Shri Ananta Nayak, Hon'ble Member, National Commission for Scheduled Tribes in the case of Shri D.S. Tomar (Sr. Manager, Dismissed) Flat No. 1210, 2<sup>nd</sup> Floor, Divyansh Partham, Opp. DPS, Indirapuram, Ghaziabad-regarding reinstatement in the services of Indian Bank.

List of participants is annexed.

Shri D.S. Toma (Sr. No. 21456, Sr. Manager, Dismissed) vide representation 05.07.2019 has stated his grievance and requested for reinstatement into service of Indian Bank to restore the sources of livelihood to his family. The NCST took up the matter with the Indian Bank for facts and comments. As per procedure adopted by the NCST the facts and comments submitted by Indian Bank was communicated to Shri. D.S. Tomar for satisfaction. Shri Tomar not satisfied with the facts and comments submitted by the Indian Bank.

Accordingly, the National Commission for Scheduled Tribes (NCST) issued Summons to Managing Director & CEO, Indian Bank for appearing before Shri Ananta Nayak, Hon'ble Member, National Commission for Scheduled Tribes on 10.02.2022 at 12:30 PM in Conference Hall, NCST, Lok Nayak Bhawan, Khan Market, New Delhi.

The MD & CEO, Indian Bank and other officer of the Indian Bank were appeared before the Hon'ble Member. The petitioner was also appeared.

The petitioner explained his grievances in detail and requested to reinstate in the service of Indian Bank. The MD & CEO informed the Hon'ble Member regarding the facts and action taken by the Bank against petitioner. It was also informed the Commission that the petitioner has filed a case before the Hon'ble High Court at Allahabad (Uttar Pradesh) regarding his grievance.

After detailed discussions with the petitioner and MD & CEO, Indian Bank, Hon'ble Member recommends that since the petitioner has filed a case before the Hon'ble High Court of Allahabad, there is no role and no action requires to be taken by NCST. However, the Hon'ble Member asked MD & CEO, Indian Bank to furnish the detail of ST beneficiaries under Mudra Yojana during last three years by the Indian Bank. The recovery percentage of the loan sanctioned by the petitioner is also informed to the Commission. The requisite information may be provided to the NCST within a month from the receipt of the minutes of the sitting/hearing.
