Minutes of sitting held in the NCST's Headquarters on 12/11/2021 at 11:30 AM under the Chairmanship of Shri Ananta Nayak, Hon'ble Member, National Commission for Scheduled Tribes in the case of Shri Rajendra Dadaji Maraskolhe, an online complaint bearing No. 172/IN/2021 regarding Compulsory retirement on caste basis by CEO, Zilla Parishad Nagpur (Maharashtra).

List of participants is annexed.

Shri Rajendra Dadaji Maraskolhe, (302, Balaji Apartment, Mankapur Faras, Nagpur) vide an online complaint bearing No. 172/IN/2021 dated 06.02.2021 has stated that the CEO, Zilla Parishad Nagpur (Maharashtra) has imposed major punishment of compulsory retirement on caste basis. The National Commission for Scheduled Tribes (NCST) vide notice dated 10.09.2021 has referred the matter to Chief Secretary, Govt. of Maharashtra, Mumbai, District Collector and Magistrate, District-Nagpur, Chief Executive Officer, Zilla Parishad, District-Nagpur and Commissioner of Police, Nagpur for facts and comments. The CEO, Zilla Parishad, Nagpur furnished the facts and comments in the matter.

NCST has decided to discuss the issue with the Collector and District Magistrate, Nagpur and CEO, Zilla Parishad, Nagpur along with petitioner on 12.11.2021 at 11:30 AM. Accordingly, the Summons was issued to concerned authorities with information to the petitioner. The sitting was convened under the Chairmanship of Shri Ananta Nayak, Hon'ble Member, National Commission for Scheduled Tribes. The CEO, Zilla Parishad, Nagpur appeared before the Commission and petitioner was also present.

The petitioner informed the Commission that he has been compulsory retired from the service under conspiracy by the employees who obtained the job on invalid Scheduled Tribes certificate. The CEO, Zilla Parishad, Nagpur reiterated the facts and comments submitted by him to the NCST.

After hearing both the parties, the Hon'ble Member make following recommendations and suggested that requisite information may be sent to the Commission within 30 days, for further examination of the case:

- The complete Departmental Enquiry report along with supporting documents against Shri Rajendra Dadaji Maraskolhe to be supplied by the CEO, Zilla Parishad, Nagpur. This includes statement of each girl student, who leveled charges against Shri Maraskolhe in Departmental Enquiry, defense of Shri Maraskolhe and other documents in departmental proceedings.
- The details of the officer(s), who were part of the Committee constituted by Zilla, Parishad, Nagpur for Departmental Enquiry against Shri Maraskolhe in October, 2018, to be supplied by CEO, Zilla Parishad, Nagpur along with their current address and positions.
- 3. Instances/cases where employees found to be working with invalid caste certificate within the jurisdiction of Zila Parishad be informed to the Commission.
- 4. It is to be clarified that whether the committee/officers who initiated Departmental Enquiry, immediately conveyed information of Cognizable offence to the nearest Police Station on receiving information of Sexual Harassment? If not, the reason thereof.

Next date of sitting in the case will be on 5th January, 2022.
