Minutes of the sitting held under the Chairmanship of Shri Ananta Nayak, Hon'ble Member, NCST, in the matter of Ms. Somari Tigga regarding the harassment, abuse,

fraud and threats hurled at her by the accused.

Date of the sitting: 16.12.22, 11.00 PM

Officials present in the sitting: As per the Annexure

In the present matter, the petitioner has stated that Ms. Somari Tigga went to Gujarat to work as a domestic help. Her employer used to abuse her. The employer did not allow her to go back home or meet her relatives. The employer also threatened her family members whenever they approached them. For 7 years, she continued to work without a break. So, her relatives approached an NGO through which the accused, Advocate Shikha Sharma agreed to help them. The NGO member along with the Advocate reached petitioner's employer's residence at Gujarat to help the petitioner. Upon reaching the employer's house, the advocate put the money and some other items in the hands of the victim petitioner and clicked photo and made video but later on collected money as the salary of the petitioner from

money to the petitioner.

In the said matter, the Commission issued notice to the Commissioner of Police, Delhi but no reply was received from the officials. Therefore, the Commission issued summons to the

the employer and brought her back to Delhi. Later on, the Advocate refused to pay back the

Commissioner of Police, Delhi on 08.12.2022.

The sitting was held on 16.12.2022 at 12.00 PM. The ACP, Netaji Subhash Palace, Delhi along with the concerned ASI appeared before the Commission as the authorized officers.

The Commission enquired about the atrocity inflicted upon the petitioner and the officials

agreed to take swift and strict action against the accused.

The Police officials expressed their inability to go through the case as it is quite old and the cause of action arose in Gujarat. However, considering the petitioner's plight as she is being harassed by the accused and other facts and circumstances the ACP assured to take all possible action. The petitioner stated that the accused took fake pictures of giving the money to the victim but in reality, she has not received any money.

The Commission takes serious note of the entire incidents and opines that the work of the petitioner as domestic help can be treated as unpaid work with use of force and the employer should be punished for such illegal acts.

After hearing both the sides, the Commission made the following recommendations: -

- The safety and security of the petitioner to be ensured.
- The detailed inquiry and impartial investigation in the said matter to be conducted.
- The eligible amount to be paid to the victim for the entire period of work.
- An Interim Report to be submitted to the Commission within 15 days.

The Commissioner of Police, Delhi to submit Action Taken Report to be submitted to the Commission within 30 days.
