PROCEEDINGS OF THE SITTING HELD ON 20.06.2022 CHAIRED BY SHRI ANANTA NAYAK, HON'BLE MEMBER, NATIONAL COMMISSION FOR SCHEDULED TRIBES (NCST) IN THE CASE OF MS. PHILISITA KERKETA, C/O SHRI SYLVESTER BAA, VILLAGE - JORAM, KHUREBAHAR, THETHAITANGAR, DISTRICT -SIMDEGA, JHARKHAND REGARDING ATROCITY, CASTE ABUSE, PHYSICAL ASSAULT AND NON PAYMENT OF SALARY TO ST WOMAN COMMITTED BY THE NON-ST EMPLOYER AND POLICE INACTION AGAINST ACCUSED.

Date of Sitting: 20.06.2022 List of officers present in sitting is Annexed.

The petitioner Ms. Philisita Kerketa, District Shimdega, Jharkhand vide her online representation dated 10.12.2021 has submitted grievances of atrocity and stated that she was working as domestic help with Talwar family at his house, Sunder Nagar, New Delhi for last 42 years. She never had any problem or ill-treatment from family members of Talwar family. Suddenly, from the 2021 onwards, one female member (Smt. Taranjit Kaur) of her employer (Talwar family) has started atrocity against her by way of using derogatory caste words, misbehaving and repeatedly assaulting upon her. Finally, she was forcefully thrown away from the house without any reasons and grounds. She had also given threat to kill, her if she (petitioner) tries to enter the house. The Talwar family has not paid full salary to her. The petitioner had demanded for action taken against the accused under SCs & STs (PoA) Act, 1989.

- 2. The Commission issued notice on 22.12.2021 for a report to the Police Commissioner, Delhi Police. However, no report was received from the Delhi Police.
- 3. Accordingly, a Sitting was held on 20.06.2022 in the Commission. In the Sitting, the Deputy Commissioner of Police, South East, Delhi Police and the ACP, South East, Delhi Police appeared. A representative from the petitioner's side was also present.
- 4. In the Sitting, the DCP (South East), Delhi Police has submitted a written report before the Commission. Further, the DCP (South East) briefed about the case and also reported that a case vide FIR No. 172/2022 dated 17.06.2022 under Section 506 IPC and 3(1) (x) SC & ST Act has been registered on her complaint at PS Hazarat Nizamuddin and presently the investigation of the case is in progress. It was also informed to the Commission that the investigation will be completed within two months.

5. The case was discussed in detail. After hearing from both parties, the Commission recommends that:

- The Delhi Police will complete the investigation in fair and unbiased manner within two months. The charge sheet will be submitted in time bound manner. It may be ensured that the accused be punished and also ensure speedy trial.
- As the FIR has been lodged under the Sections of SCs & STs (PoA)
 Act, 1989 and hence, the victim compensation at FIR stage under the
 provisions of SCs & STs (PoA) Act, 1989, Rules 2016 and amended
 Rules, 2018 be provided to the victim ST woman. The remaining
 amount of compensation may also be released after filing charge sheet
 before the Court and conviction of accused.
- The action taken report on the Commission's recommendations should be submitted before the Commission within the stipulated period of two months.
