Minutes of the Sitting held under the Chairmanship of Shri Ananta Navak, Hon'ble Member, NCST, in the matter of caste based abuse, physical assault and outraging the modesty of the petitioner Ms. Shikha Meena.

Date of the Sitting: 06.02.2023; 03.00 PM

Officials present in the sitting: Deputy Commissioner of Police, South East, Delhi

The petitioner through her complaint brought before the Commission that she resides at Jangpura, New Delhi and was abused with caste based remarks, assaulted and beaten by the accused. She also stated that she was harassed and her modesty was outraged by the accused. Even the police delayed to take action and did not insert the provisions of Section. 354 of the Indian Penal Code, 1860 and the provisions of SC/ST (POA) Act, 1989.

The Commission issued Notice to the Commissioner of Police, Delhi dated 15.11.2022. Since no reply was received, the Commission issued Summons to the Commissioner of Police, Delhi. The Deputy Commissioner of Police, South East, Delhi appeared before the Commission with replies.

The Commission sought to know from the Deputy Commissioner of Police, South East, Delhi why there is so much delay in submission of replies and why the provisions of SC/ST (POA) Act, 1989 were not inserted along with Section 354 IPC Act, 1860.

The Deputy Commissioner of Police, South East, Delhi informed that they inserted the provisions of SC/ST (POA) Act, 1989 after receiving the copy of Summons. The Police did not find cause of caste indicative discrimination. She also stated that they will add Section 354 IPC Act, 1860.

The petitioner further stated that the incident was circulated on WhatsApp groups and participants of the group used caste indicative remarks and threatening words against the petitioner and her family.

The Commission asked the DCP, South East, Delhi whether the petitioner has been paid any compensation under SC/ST (POA) Act, 1989 and whether relevant provisions of the Information Technology Act, 2008 can be inserted. The Deputy Commissioner of Police, South East, Delhi replied affirmatively.

After hearing both the sides, the Commission recommended the following:

The Deputy Commissioner of Police, South East, Delhi

- to ensure relevant provisions of SC/ST (POA) Act, 1989; Section. 354 of IPC, 1860 and relevant provisions of Information Technology Act, 2008 to be inserted in the FIR.
- to expedite the investigation in an independent and impartial manner and ensure payment of compensation under SC/ST (POA) Act, 1989 and send a comprehensive report with compliance of the recommendation within 15 days.
