Sir/Madam,

I am directed to refer to the above-cited subject and to say that your representation /complaint dated nil is addressed to the Hon'ble Minister of Tribal Affairs, Govt. of India which was received through PS to Hon'ble Minister of Tribal Affairs vide note dated 03.09.2021 regarding compensation in lieu of their acquired land by the Bhilai Steel Plant.

2. In this connection, it is intimated that the matter was taken up with the District Collector, District- Balod, Chhattisgarh vide NCST Notice dated 06.10.2021. In response to the Commission's Notice, a reply dated 05.09.2022 was received from the Sub-Divisional Officer (Revenue), Daundi Lohara, District- Balod. The Copy of the reply was forwarded to the complainant vide Commission's letter dated 04.10.2022 for information.

3. It is reported in the reply of SDO (R), Daundi Lohara, the compensation has been paid by the Bhilai Steel Plant vide their letter dated 25.02.1967 for their acquired land. In this regard, it is pertinent to mentioned that no further representation/complaints have been received from the complainant to the Commission.

It seems that the grievances of Sh. Lal Bhupendra Singh Tekam and Others have been resolved.
