Sub: Representation dated 23.02.2023 by Shri Thenkhogin Haokip, Chief of Kungpi Naosen Village, Kangvai Block, Churachandpur, Manipur 'regarding quashing of the Churachandpur Khoupum Protected Forest, Manipur Gazette, Extraordinary, Published by Authority, No.124-E100, Imphal, Wednesday, September 21, 1966, (Bhadra 30, 1883) No. 55/10/66-M(2), Government of Manipur, Secretariat: Forest Branch, Notification, Imphal, the 17th September, 1966, and withdrawal of the Show Cause Notice, Noney, the 10th August, 2022 issued to the village of 1. K.Hengmol 2. K.Songjang, Both, Hemlet of Kungpi Naosen Village by Shri. Napolean Rongmei, Divisional Forest Officer, Noney Forest Division, Government of Manipur, and compensation for the 17 houses destroyed with the wrongful use of Police force by the said DFO, Noney Forest Division, Government of Manipur on dated 20th February, 2023.

Whereas a petition/complaint/information has been received by this Commission from **Shri Thenkhogin Haokip and others dated 23.02.2023** as enclosed and the Commission has decided to investigate/inquire into the matter in pursuance of the power conferred upon it under Article 338A of the Constitution of India. You are hereby requested to submit the facts and information on the action taken on the allegations/matters to the undersigned **within 15 days** of receipt of this notice either by post or in person or by any other means of Communication.

Please take notice that in case the Commission does not receive reply from you within the stipulated time, the Commission may exercise the powers of Civil Court conferred on it under of Article 338A of the Constitution of India and issue summons for your appearance in person or by a representative before the Commission.
