Minutes of the Sitting held under the Chairmanship of Shri Ananta Nayak, Hon'ble Member, NCST in the Shri Rishya (Rishu) VajyaKharpade, Village Sutrakar (Katilpada), Talasari Tehsil, Palghar District, Maharashtra Matter

Date of the Sitting:08.02.2023

Participants in the Sitting: As per Annexure

The Petitioner Shri Rishya (Rishu) VajyaKharpade, Village:Sutrakar (Katilpada), Tal: Talasari, Dist: Palghar (M.S.) in his petition stated that he was holding the agriculture land bearing Survey No. 370/4 admeasuring 0.28.00 R. Hec.. He submits that since the Land Records Department has not done proper demarcation of his land, the adjacent land owner quarreling with him. Petitioner leveled allegation that in the absence of demarcation some of his area has been encroached by adjacent land owner.

The petitioner has request District Land Record Department to make proper demarcation. Concern authority directed petitioner to pay the charges of entire survey number so that they will start the demarcation work. Since he is not having a financial capacity to pay a huge government charge for measurement of entire survey number therefore, the dispute is still pending between them and concern authority has not taken any action in this regard. Seeking intervention of the Commission, the petitioner request for justice.

Taking cognizance of the petition, on 09/11/2022 the Commission issued Notice to Shri. Govind Maruti Bodke, Collector and District Magistrate, Palghar District to submit an action taken report within 15 days.

On 22/11/2022 Deputy Superintendent of Land Records, Tal: Talasari, Dist: Palghar has submitted enquiry report stating the applicant wants to measure his land Survey No.370/4 area 0.28 H.R. Situated at Village: Sutrakar, Tal:Talasari Dist. Palghar to be surveyed and independent survey map be prepared. Accordingly, comparing the available record of Sr.No.370/4 area 0.28 H.R. situated at Village: Sutrakar, Tal:Talasari, Dist: Palghar available with the Talathi Office a discrepancy is found on record. After re-measurement of the said survey No.370, they will submit a final report after the measurement survey is completed by the concern authority.

The Commission carefully examined the case and issued Summons to Shri. Govind Maruti Bodke, Collector and District Magistrate, Palghar District to appear for hearing on 08th February 2023

During the hearing of the matter District Collector stated that there are many areas in which wrong demarcation was done since long time. He also stated that since the entire area is Scheduled Area and many parts of this district is coming under the Green Zone declared by the Central Government. The Collector also informed that this area is geographically isolated area and therefore, land measurement work is very challenging and tedious task.

The District Collector also admitted that as per rule, petitioner require to pay the fees for entire survey number and not only for his area. In the state of Maharashtra there is no scheme is in existence where fees required to demarcation of land will be bear by the Government in case of Scheduled Tribe.

After hearing both the sides, the Commission recommends the followings: -

- 1. The Additional Chief Secretary, Tribal Development Department, Mantralaya, Mumbai-32, Commissioner, Tribal Development, Nashik with the help of Additional Chief Secretary, Revenue Department, Mantralaya, Mumbai-32, Principal Secretary, Forests Department, Mantralaya, Mumbai-32 and Additional Chief Secretary, Finance Department, Mantralaya, Mumbai-32 can formulate the Scheme for bearing the expenses of the land measurement and demarcation for Scheduled Tribes in the state of Maharashtra. This scheme should be implemented through ITDP of the Tribal Development Department.
- 2. The Collector shall ensure that the measurement and demarcation expenses of the present Petitioner should be recovered from ITDP, Tribal Development Department, Palghar from this new Scheme and proper demarcation shall be made without any fees and also remove the encroachment if any found after measurement and handover the accurate land to the petitioner within period of 30 days from the date of measurement of said survey number.
- 3. That detailed Action Taken Report about the formation and implementation of new scheme as recommended herein above shall be submitted to the Commission by the Tribal Development Department within period of 30 days.
