## National Commission for Scheduled Tribes

#### NCST/ATY-564/TS/11/2022-APCR

Minutes of the Sitting held under the Chairmanship of Shri Ananta Nayak, Hon'ble Member, National Commission for Scheduled Tribes at Hyderabad, in the case of Shri Dharavathu Ramadasu, National President, Justice for people Right Forum, Khammam, Telangana regarding inaction even after lodging of FIR by Smt. Dharavat Jyothi against P.V. Sathyanarayana Reddy.

Date of the Sitting: 15.03.2023; 12.00 PM

This is in continuation of the earlier proceedings. The fact of the case is that the victim, Mrs. Dharavat Jyothi, has stated that she approached the police station several times in regards to the harassment and threats inflicted upon her by the accused.An FIR was lodged but allegedly, the investigation was conducted partially as the Investigation Officer has closed the matter due to lack of substantial evidence. She has stated that she and her husband are being trapped in a false case of credit and non-payment of dues.

The Commission issued Notice to the Commissioner of Police, Khammam, Telangana on 30.08.2022. Pursuant thereto the Commission received the reply from the Office of Commissioner of Police, Khammam. According to the reply, the enquiry has revealed that the case is completely false and there are financial differences between the alleged accused and the petitioner. The petitioner and her husband took huge amounts of Rs. 9 lacks and 16 lacks by giving promissory notes and bank cheques for doing minor contract work. As per the enquiry, the case of non-payment of credit and dues has been filed before the Learned Civil Court vide Case. No. 41/2022 and 40/2022. As per the enquiry, the allegations levelled by the petitioner are false and baseless.

The Sitting was held on 08.11.2022. The Commissioner of Police, Khammam, Telangana appeared before the Commission. The Commission recommended that the concerned officials to re-enquire the matter impartially and independently and submit the Action Taken Report in 15 days. The Commissioner of Police, Khammam submitted an Action Taken Report which stated that the contents of the petition were found false and the matter does not attract the relevant sections of IPC, 1860 and SC/ST (PoA) Act, 1989.

Subsequently, the Sitting was held on 15.03.2023 under the Chairmanship of Hon'ble Member, NCST, Shri Ananta Nayak and the Commissioner of Police, Khammam, Telangana appeared before the Commission.

The Commission asked the petitioner to raise his concerns. The petitioner provided the evidence of text messages and call records as a proof of harassment that is being inflicted upon her. She also stated that they have been trapped in a false case and constant threats are being given to her and her husband. The Commission agreed that the petitioner is being inflicted through mental harassment and on the basis of the additional documents, independent enquiry to be made afresh.

- (i) To conduct an independent and impartial investigation in the matter on the basis of the additional documents to find the discrepancies.
- (ii) The Commissioner of Police may consider change of Investigation Officer and get the matter re-enquired independently and impartially.

An Action Taken Report with compliance of the Recommendations be submitted to the Commission within 15 days.
