Respected Sir,

With due respect and humble submission I shri Basanta Kumar Singh aged about 48 years S/o Late Lalmohan Singh, by caste- Bhumija (S.T.) resident of Village- Madhupur, PC- Jadunathpur, under PS- Badasahi in the district of Mayurbhanj, State Odisha beg to draw your kind attention and sympathetic orders for the following few lines that I am a bonafied customer of State Bank of India, Budhikhamari Branch of District Mayurbhanj since 2007. In the years of 2007, I was applied for a Tractor loan from the said Bank. The Bank had deducted Rs. 85,829/- (Rupees eighty five thousand eighty hundred twenty nine only) from my SB Account vide A/c No. 01170076503 towards the margin money on dated 13.03.2007 and the land record of my house(patta) also with the bank towards security of the loan. Schedule of property as follows; vide Khata No.610 in mouza-Baunsabila, Tahasil- Samakhunta, and khata no.166 in mouza- Madhupur, tahasil-Badasahi in the district of Mayurbhanj which is recorded in the name of my parents. Subsequently my above said S.B. A/c No. changed to S.B. A/c No. 11/5539398 since then I am requesting the bank to avail the loan for the tractor but unfortunately the said bank did not turn. Neither the Bank authority returning the said margin money nor sanctioning the loan in my favour. further I am to state that myself in a state of harassment, with so much mental agony. Though a period of one and half decade been passed and I am wondering from post to pillar nobody is responding to a poor person like me for which I am suffering a financial crunch as well as my bread and butter in stake.

Therefore I pray to your goodself consider my light and take initiative to enquire the matter and give justice to me for which I shall be obliged.
