

Minutes of the Sitting held under the Chairmanship of Shri Ananta Nayak, Hon'ble Member, NCST, in the case of Shri Bhukya Rambabu and others regarding the Compensation for affected individuals are not given according to the Rehabilitation and Resettlement (R&R) package by Singareni Collieries Company and the District Administration.


Date of the Sitting: 30.06.2023

In the representation dated 19.02.2023, Smt Uke Ashirwadham & others, a resident of Jagannadhapuram Village, Bhadradi Kothagudem District submits that the Singareni Collieries Company and the District Administration, India, failed to fulfill promises made during land acquisition. They forcefully evacuated the petitioners and provided only Rs. 7,61,000 instead of the promised Rs. 11,64,000. Compensation for affected individuals was not given according to the Rehabilitation and Resettlement (R&R) package. Employment was guaranteed for one household member, but only three families received it. Kistaram village received higher compensation for agricultural land and eucalyptus plantation than the petitioners. Promised infrastructure such as schools, community halls, temples, roads, and a burial ground remain undeveloped. An inquiry is urgently needed to ensure justice for all affected individuals.

Considering the gravity of the issue raised before the Commission, Notice was issued to the District Collector, Khammam District Chairman-cum-Managing Director, Singareni Collieries Company Limited, Bhadradi Kothagudem District to submit the Action Taken Report ("ATR") within 15 days. No action report is submitted during the expected time limit.

The petitioner has submitted a rejoinder stating that till date, Singareni Collieries Company Ltd and the District administration have not considered any of their requests and have failed to take any action. They are merely making false promises of completing the work but have not taken any concrete action yet.

The lackadaisical attitude towards addressing the alleged claims mentioned in the petition has been examined by the Commission. Summons dated 08.06.2023 were issued to Shri N. Sridhar, Chairman-cum-Managing Director, Singareni Collieries Company Limited, Kothagudem Collieries, Bhadradi Kothagudem District to appear before the Commission on 30.06.2023 for Sitting.

During the hearing on 30.06.2023, the Petitioner submitted that the Singareni Collieries Company in Telangana and the District Administration have failed to fulfill the promises made during the land acquisition process. They forcibly evacuated the petitioners and provided only Rs. 7,61,000 instead of the promised amount of Rs. 11,64,000. The District Administration and the company have not compensated the affected individuals as per the Rehabilitation and Resettlement (R&R) package. Furthermore, Scheduled Tribes were given less compensation compared to other categories of people. Although employment was guaranteed for one member per household, only three families received it, leaving the rest deprived. In contrast, Kistaram villagers received Rs. 20,00,000 per acre for agricultural land compensation and Rs. 4,00,000 per acre for eucalyptus plantation, while the petitioners were given significantly less, specifically Rs. 16,50,000 for agricultural land and an insufficient amount for eucalyptus. The promised infrastructure and amenities such as schools, community halls, temples, roads to agricultural lands, and a burial ground have not been developed. Urgent action is needed to conduct an inquiry and ensure justice for all affected individuals.

Shri N. Balaram, Director (PA&W), appearing on behalf of the Managing Director of Singareni Collieries Company Limited, Kothagudem Collieries, Bhadradi Kothagudem District, stated that the acquisition process, compensation, and rehabilitation of displaced persons were managed by the district administration. The issues concerning the company are related to employment and development works, R&R (Resettlement and Rehabilitation) has been provided to the petitioners as per the Law. The petitioners received the choice of annuity as per Schedule-II of the Act. Therefore, employment provision does not arise. A few people have obtained contract jobs in outsourcing works based on their skills and qualifications. Regarding development works, an R&R center has been developed in Cherukupalli in a phased manner. In the first phase, basic amenities

such as an overhead tank, CC roads, drains, a temporary school building, an Anganwadi building, and a temple were constructed. In the second phase, a permanent school building, a function hall, a temple, a church, and a culvert over the Nallah crossing point of Phase I & Phase II sites in the R&R center are under construction. The sand cement lining to the existing Nallah works is currently in progress.


The Commission expressed serious disappointment over the lapses and lackadaisical attitude of the authorities in addressing the issues mentioned in the petition despite considerable time passed. The Commission calls for action on top priority.

After the hearing, the Commission recommends the following: -

1. The Managing Director of Singareni Collieries Company Limited, will constitute a team comprising senior authorities to visit the site and assess the ground situation. Based on the observations, the team will work towards resolving the issue and submit a report within 30 days.
2. The Managing Director of Singareni Collieries Company Limited, shall ensure that permanent school building, a function hall, Anganwadi building, temple and roads within 6 months.
3. The Managing Director of Singareni Collieries Company Limited, will co-ordinate with the District collector on all the issues raised by the petitioners and send the compliance report within 30days.
4. The Managing Director of Singareni Collieries Company Limited, shall provide a copy of the R&R (Resettlement and Rehabilitation) policy to the Commission within 7 days.

Action Taken Report with compliance of the Recommendations has to be submitted within 30 days for further perusal of the Commission.

In the meantime, Notice to Commissioner, Rehabilitation and Resettlement (R&R), Telangana and Divisional Forest Officer, Bhadradi Kothagudem District shall be issued seeking ATR within 07 days.
