Minutes of the Sitting held under the Chairmanship of Shri Ananta Nayak, Hon'ble Member, NCST on representation dated 29.07.2020 from Shri Kisan Ganju, Village Naudiha Godhwar, Post-Saradhu, Thana-Tandla, District-Chatra, Jharkhand regarding the compensation of the land acquired by NTPC Limited in village Nawadih of Hazaribagh district in the State of Jharkhand.

Date of the Sitting: 15.06.2023 (Thursday) at 03:30 PM



The Commission received a representation from Shri Kisan Ganju, stating that National Thermal Power Corporation ("NTPC") had acquired land in Nawadih Khata village, Jharkhand, including 04, 05, 06, 02, and 420 of Keredari circle. The land mafia in the area used fake documents to obtain compensation for the North West Project in Pakri Barwadih Coal Block. It is also stated that many ancestral lands were also acquired by NTPC without due compensation and proper rehabilitation.

Considering the gravity of the issue, the Commission issued Notice on 01.09.2022 to the Deputy Commissioner, Hazaribag District and the Chairman and Managing Director, NTPC to take necessary action and submit the Action Taken Report within 15 days.

Pursuant thereto, the Commission received ATR dated 08.09.2022 from NTPC stating that NTPC's role is limited with regard to the disbursement of compensation on the basis of land ownership certification issued by District Revenue Authorities and that they had no authority / ownership over the revenue records of Jharkhand government. It was further stated that till date, compensation has not been disbursed by NTPC to any claimant.

The Commission received ATR dated 06.10.2022 from Deputy Commissioner, Hazaribagh, Jharkhand stating that in Nawadih village, only Account No. 0-410 Rqua 0.93 has been dedicated for the SIA process by the requisitioning department. Therefore, action is required from the District Land Acquisition Officer in Hazaribagh and Deputy General Manager (Land Acquisition) at Pari Barwadih and Pakri Barwadih North West Coal Mining Project NTPC.


The Commission issued Summons dated 02.05.2023 to Shri. Gururaj Singh, Chairman and Managing Director, NTPC to appear before the commission on 15.06.2023 at 03:30 PM for Sitting.

During the course of hearing on 15.06.2023 Shri.Dilip Kumar, Director,NTPC submitted that the land acquisition is acquired by the district authorities. NTPC only checks the irregularities in the documents. It was further submitted that currently, the complete process of land acquisition is yet to be complete. The NTPC has set up Public Grievance Centers where any grievance against NTPC by the public may be raised at these centers. To ensure proper redressal of the grievances received, locals are deputed at these centers. It was further submitted that all the grievances received at these centers were looked into in carefully and were also forwarded to the District Collector who held Sittings twice every week. The NTPC ensured that all the grievances were properly addressed.

After hearing the case, the Commission recommends the following: -

1. The Chairman and Managing Director, NTPC will furnish all the documents that it received from the District Collector, Hazaribagh, Jharkhand regarding the project.
2. The District Collector, Hazaribagh, Jharkhand will verify the Survey Numbers pertaining to the Petitioner
3. The District Collector, Hazaribagh, Jharkhand and the Chairman and Managing Director, NTPC will furnish complete details of the proposed compensation, resettlement and rehabilitation to be awarded to the people whose land are to be acquired.
4. The Chairman and Managing Director, NTPC has to ensure that the Public Grievance Centers are looking into all the grievances in detail. In addition to the document verification, NTPC shall also conduct field verifications for the redressal of the grievances.

Action Taken Report with compliance of the recommendations to be furnished within 30 days for further perusal of the Commission.
