Minutes of the Sitting held under the Chairmanship of Shri Ananta Nayak, Hon'ble Member, NCST on representation dated 23.11.2021 of Shri. Kallu Urf Dilip Dhruve regarding grabbing of his agricultural land.

Date of the Sitting: 14.06.2023 (Wednesday) 03:30 PM

The Commission received a representation dated 23.11.2021 from Shri. Kallu Urf Dilip Dhruve stating that one non-tribal had illegally grabbed and taken possession of his agricultural land in Mandla, Madhya Pradesh.

Considering the gravity of the issue, the Commission issued Notice on 07.05.2022 to the District Collector, Mandla, Madhya Pradesh to take necessary action and submit an Action Taken Report within 15 days.

The Commission received Action Taken Report from the District Collector, Mandla, Madhya Pradesh stating that they had issued order dated 10.02.2023 to remove the people who have illegally taken possession of the Petitioner's land.

The Commission issued Summons dated 05.06.2023 to the District Collector, Mandla, Madhya Pradesh to appear before the Commission on 14.06.2023 at 03:30 PM for Sitting. During the course of Sitting on 14.06.2023 the Petitioner submitted that although an order was issued by the District Collector, Mandla, Madhya Pradesh, it was not executed. The non-tribal miscreants were still in illegal possession of the agricultural land. The Petitioner was still awaiting the district authorities to execute the order and handover the peaceful possession of his land.

Shri Ranjith Gupta, Area organizer, Deputy Director, Tribal Department, Mandla Madhya Pradesh submitted that they had issued an order of eviction in favour of the Petitioner. Smt. Saloni Sidana, District Collector, Mandla, Madhya Pradesh did not appear before the Commission



The Commission takes serious note on the repeated absence of the District Collector, Mandla, Madhya Pradesh with respect to the Summons issued by the Commission. Despite receiving multiple Summons, the District Collector, Mandla, Madhya Pradesh has failed to appear before the Commission and has failed to provide any legitimate reason/ lawful excuse for the absence. The Commission notes the lapses and the lackadaisical attitude of the District Collector, Mandla District, Madhya Pradesh.

In view of the above, the Commission recommends the following: -

1. The District Collector, Mandla, Madhya Pradesh will ensure proper demarcation and execution of the order through the concerned authorities and ensure that the Petitioner receives back the peaceful possession of his land.

Action Taken Report with compliance of the recommendations to be furnished within 15 days for further perusal of the Commission.
