#### NATIONAL COMMISSION FOR SCHEDULED TRIBES

Minutes of Meeting held on 06.10.2023 Chaired By Shri Ananta Nayak, Hon'ble Member, National Commission for Scheduled Tribes (NCST) in the case of Shri Kuthadi Srinivas S/o Shri K. Narsimha, H. No. - 11-74, Sriram Nagar Colony, Chennapuram, Balaji Nagar, Shamirpet Mandal, District Medchal-Malkajgiri, Telangana State regarding implicating in false cases and threatening to compromise.

Date of Meeting: 06.10.2023 List of participants Annexed.

The Commission received a representation dated 04.11.2022 received from Mr. Kuthadi Srinivas S/o Shri K. Narsimha, H. No. - 11-74, Sriram Nagar Colony, Chennapuram, Balaji Nagar, Shamirpet Mandal, District Medchal-Malkajgiri, Telangana State regarding implicating him in false cases and threatening to compromise. The petitioner states that the petitioner and Shri Lakshmikanta Panda were business partners in real estate, cold storages, warehousing etc since 2018. Shri Lakshmikanta Panda having certain issues which ended up in civil litigation. There is an ingredient of instigation to another person and started filing false cases against the petitioner and further threatened the petitioner that if he does not compromise, then he will go ahead and start filing cases under the Prevention of Dangerous Activities Act (PD Act). The petitioner has reported to the SHOs of Jawaharnagar, Neredmet, Basheerabad and Medchal, the Commissioner of Rachkonda, Commissioner of Police, Cyberabad and DGP, Telangana but no action has been taken by the authorities.

- 2. The Commission took up this matter with DGP, Telangana, Commissioner of Police, Rachkonda and Commissioner of Police, Cyberabad on 14.12.2022.
- 3. In response to the Commission's notice dated 14.12.2022, the Commissioner of Police, Rachkonda vide its letter dated 22.12.2022 has submitted a report. In the report, they stated that the petitioner and Shri Lakshmikanta Panda had executed development agreement between themselves for joint development on the land belonging to the petitioner. The petitioner had promised that he and his family members will furnish all the necessary documents and get the agreement notarised. But Shri Lakshmikanta Panda later found that the lands that was promised by the petitioner belonged to the Government and not to the petitioner. Thereafter, Shri Lakshmikanta poanda lodged complaints against the petitioner. A total of 17 cases have been lodged against the petitioner in different Police Stations and a Rowdy Sheet is also maintained at Jawaharnagar Police Station. They also reported that he didn't respond and didn't turned up to the Police Station for resolving of his grievances. The petitioner has raised baseless allegation regarding false cases implicated against him.
- 4. The report was forwarded to the petitioner on 19.01.2023 for information and comments.
- 5. The petitioner was not satisfied with the report of Commissioner of Police. He submitted a rejoinder dated 20.03.2023 that out of the 17 cases listed out in the ATR of Commissioner of Police, Rachakonda, 12 cases have already been closed on various grounds of being quashed by the High Court, closed by the Police for lack of evidence or after entering compromise. In the other 5 cases, the High Court had granted interim orders in favour of the petitioner. Apprehending a threat of being arrested under the PD Act, the petitioner filed for



anticipatory bail before the High Court and the High Court had granted interim order in favour of the petitioner. But despite this the Police of Cyberabad arrested the petitioner while he was performing the marriage of second son.

6. Earlier a Sitting was held on 27.04.2023. In the Sitting dated 27.04.2023, the DCP, Malkajgiri, DCP, Medchal, Rachkonda and ACP, Bhasheerabad were appeared before the Commission. In the sitting dated 27.04.2023 the Commission recommended that:-

To take appropriate action as per applicable laws in the facts and circumstances of the case. To conduct a fair and unbiased investigation based on the complaints filed by the petitioner and submit ATR on the same.

An action taken report submitted by the Dy. Commissioner of Police, Medchal Zone, Cyberabad on 17.05.2023. In the report, it has been mentioned that since Kuthadi Srinivas has been repeatedly committing criminal cases since the year 2003 and taking law into his hands by creating panic amongst innocent law abiding civilians, a rowdy sheet was opened against him at Jawaharnagar PS vide the order in Proceedings 1105/ACP-A/Cyb/2013 dated 26.11.2013 of ACP, Alwal Division, Cyberabad. He is still an active Rowdy Sheeter of Alwal PS. Since his criminal acts went out of control he was detained under "Preventive Detention Act" vide order No. 17/PC/CCRB/Cyb/2015 dated 17.08.2015. However, soon after he got release order, and though close surveillance was maintained against him, he did not stop crime and showed no respect towards the law. Unable to tolerate his atrocities, the innocent victims even approached mainstream media against him seeking justice. Almost entire print media covered this news with banner heading debunking the notorious and antisocial activities of Kuthadi Srinivas. In order to stop and deter him from continuing such criminal acts against common public he was detained under "Preventive Detention Act" once again vide the order No. 08/PD-CELL/Cyb/2023 dated 07.02.2023.

- 7. ATR/ reply of DCP, Medchal was examined and perused by the Commission. Thereafter, a meeting has been fixed on 06.10.2023 with the Director General of Police, Telangana and Commissioner of Police, Cyberabad, Telangana. Accordingly Meeting letter dated 27.09.2023 has been sent to the concerned authorities.
- 8. On behalf of Director General of Police, Telangana, Deputy Commissioner of Police, Medical Cyberabad, Assistant Commissioner of Police, Cyberabad and Inspector of Police, Medchal appeared before the Commission. The petitioners were also present in the Meeting.
- 9. The matter was discussed in detail. The petitioner submitted to the Commission that there is no case/complaint against him and his family since 2003 to 2015. He has started a business with a partnership with Shri Lakshmikanta Panda on his land in 2018 in real estate, cold storage, warehousing etc. Shri Lakshmikanda Panda instigated another person and started filing false cases against him and further threatened him that if he does not compromise, then he will go ahead and start filing cases under the Preventive of Dangerous Activities Act (PD Act). He has submitted that out of 17 cases listed out in the ATR of Commissioner of Police, Rachakonda, 12 cases have already been closed on grounds of it being quashed by the High Court, closed by the Police for lack of evidence or after entering compromise. In the other 5 cases, the High Court had granted interim orders in his favour. He is also apprised that a Rowdy Sheeter case has been charged against his family in the Alwal Police Station.

- 10. The concerned authority of Police Department submitted to the Commission that the business was started by Shri K. Srinivas with the partnership of Shri Lakshmikanta Panda on Government land. Thereafter some disputes has been raised by both partners. The Police authorities submitted that 20 FIRs has been registered against Shri Kuthadi Srinivas. All FIRs has been registered on the basis of complaint against Shri K. Srinivas by the SC/ST/OBC persons. The concerned authorities also submitted that out of 20 FIRs, only 5 FIRs are pending, 3 FIRs under investigation, 2 FIRs are completed, 1 is acquittal, 6 FIRs are quashed and 1 FIR is civil nature. The Police Officials vehemently opposed the allegations of the petitioner. It has been categorically stated that there are several allegations against the petitioner for illegal activities.
- 11. After hearing, the Commission recommends that:
  - The Police authority to take necessary action against Shri K. Srinivas as per Rule.
  - The Commission does not find any merit in the allegations by the petitioner and hence does not want to interfere in the matters against Shri Lakshmikant Panda.
  - Investigation to be completed timely in all the five pending cases against Shri K. Srinivas.
  - Factual/status report of disputed land i.e. private land or government land on which business was started by Shri K. Srinivas and Shri L. Panda be submitted to the Commission.
  - Copies of FIRs registered against Shri K. Srinivas to be furnished to the Commission.
  - In future, the Police Department not to take action against the petitioner's family during his traditional/family functions unless the allegations are so wild and heinous
  - Report/documents of Rowdy Sheeter case registered against the petitioner's son to be submitted to the Commission.

The action taken report in the matter should be submitted before the Commission within 15 days.
