Minutes of the Meeting held on 19.12.2023 Chaired By Shri Ananta Nayak, Hon'ble Member, National Commission for Scheduled Tribes (NCST) in the case of Shri Kuthadi Kumar, H No. 5-2-85/1 Yapral, Medchal Malkajgiri, Telangana regarding caste based abuse, instigating the public to beat the petitioner, trespassing and damage of petitioner's property by Mynapally Hanumantha Rao, Member of Legislative Assembly, Malkajgiri Constituency, Telangana.

Date of Meeting: 19.12.2023

The Commission received representation from Shri Kuthadi Kumar, Medchal Malkajgiri, Telangana regarding caste based abuse, instigating the public to beat the petitioner, trespassing and sabotaging petitioner's property. He alleged that he had entered into an agreement of sale with Smt. Sowbhagya Vathi Badhey and others (vendors). The vendor's mother's name was incorporated into the revenue land records and they are the absolute owners of the land. To protect the said land, the petitioner erected blue sheets around the land. On 30.10.2022, Shri Mynampally Hanumantha Rao, Member of Legislative Assembly, Telangana State and his associates trespassed into the vendor's land and demolished the blue sheets erected by the Petitioner, passed derogatory caste based remarks towards the Petitioner and instigated the tenants and general public near the land to beat him up.

- 2. The Commission took up this matter with the Chief Secretary, Government of Telangana and Director General of Police, Government of Telangana on 02.12.2022. Since no reply was received pursuant to the Commission's notice from the concerned authority in the matter, a Sitting was fixed on 27.04.2023 with the concerned authority in the Commission.
- 3. Accordingly, Sitting was held on 27.04.2023. wherein the Commission recommended the followings:
 - To take appropriate action as per applicable laws in the facts and circumstances of the case.
 - To change the present investigation officer with another competent officer to conduct a fair and unbiased investigation in the matter and submit ATR on the same within 15 days.
 - To furnish all the evidences and documents wherein the police recorded the absence and non-cooperation of the petitioner for enquiry and investigation purposes within 15 days.
- 4. Minutes of the Sitting was forwarded to the Chief Secretary, Government of Telangana and DGP, Telangana on 12.06.2023.

5. An ATR received from the Commissioner of Police, Cyberabad, and DGP, Telangana a dated 21.06.2023 and 24.06.2023 respectively and reported that action has been taken under the law.

- 6. On perusal of ATR, the Hon'ble Member has fixed a meeting on 19.12.2023 On behalf of Director General of Police, Telangana, Deputy Commissioner of Police, Medical Cyberabad, Assistant Commissioner of Police, Cyberabad were appeared before the Commission. The petitioner was also present in the Meeting. The matter was discussed in detail. During the discussion/hearing petitioner submitted that proper action has not been taken by the Police in his matters. He has requested that Rowdy Sheeter case may be removed in his case.
- 7. The concerned authority of Police Department submitted to the Commission that as per recommendation of the Commission held in the Sitting on 27.04.2023 all actions are taken by the Police in the cases of Shri Kuthadi Kumar. Action on Rowdy Sheeter case against Shri Kuthadi Kumar has been taken as per Law.
- 8. After perusal of the reports and submission of the petitioner, the Commission fixed for a Sitting.
- 9. During the course of hearing the Police Authority stated the sequence of the events. The Authority categorically stated that there is absolutely no illegalities committed by the Police. The investigation of the FIR is going on. The petitioner before the Commission has also been accused in criminal cases. The witnesses are duly examined.

Responding to the submissions of the police, the petitioner narrated his background and police high handedness. He further stated that the cases against him ended up in acquittal and compromise. Therefore term of Rowdy sheeter is not applicable to him. The police not investigating the case properly. There is no arrest of the accused so far. He sought for further action by the Police and suitable recommendations from the Commission.

- 10. After the hearing, the Commission recommends the followings :
 - The Case of Rowdy Sheeter against the petitioner may be re-looked and reconsidered.
 - The petitioner may not be harassed mentally by the Police during the investigation.
 - Action by the Police on the complaints against Shri Kuthadi Kumar and by the Kuthadi Kumar may be taken as per Rules and Procedure by the Police in complete fairness.
 - No further action is required by the Commission in the matter of Shri Kuthadi Kumar.
