


Shri S Ravi Naik, Executive Engineer, Transport, Roads and Building Department, Govt. of Andhra Pradesh vide representation dated 26.07.2023 had alleged that the Road and Building Department, Govt. of Andhra Pradesh is harassing him by not considering him for promotion to the post of Superintendent Engineer.

2. The Commission vide Notice dated 09.08.2023 had taken up the matter with Principal Secretary, Transport, Roads and Buildings Department, Govt. of Andhra Pradesh calling for facts and comments. No response was received from the Authority.

3. The Commission therefore decided to discuss the issue with Principle Secretary, Transport, Roads and Building Department, Govt of Andhra Pradesh and Petitioner on 06.11.2023 at 03:00 PM and accordingly, the Authority and Petitioner were informed vide NCST Letter dated 20.10.2023.

4. The Principal Secretary, Transport, Roads and Building Department, Govt of Andhra Pradesh vide Letter No. 2214244RDBS0MISC/523/2023-SER-RB dated 31-10-2023 intimated the Commission that the Petitioner has filed WP No 15190/2023 before the Hon'ble Andhra Pradesh High Court which is sub-judice. The Engineer in Chief (R&B) Administration, Govt of AP who appeared before the Commission reiterated the above facts conveyed by the Principal Secretary, Transport, Roads and Building Department during the meeting. The Petitioner was also present during the Meeting and concurred that the case is sub-judice.

5. After hearing both the parties, the Commission has decided not to pursue the matter as the subject matter of the petition is sub-judice before the Hon'ble High Court of Andhra Pradesh.
