Minutes of the Hearing chaired By Shri Jatothu Hussain, Hon'ble Member, NCST on 13.06.2024 in the case of Shri Jarupula Ramesh, Village- Beechurajupalli, (Jarupula Thanda) Purushottayugudem, Post- Maripede Mandal, District -Mahabubabad, Telangana.

A representation dated 06.05.2023 was received in the NCST from Shri. Jarupula Ramesh R/o Village- Beechurajupalli, (Jarupula Thanda) Purushottayugudem, Post-Maripede Mandal, District -Mahabubabad, Telangana. Where in he stated that Shri. Nookala Naresh Reddy has illegally grabbed his land and ruined the crops, which was his only source of livelihood. He has verbally abused the Petitioner with derogatory caste based remarks, illegally fenced the land of Petitioner and sold the chilly crop sown by the petitioner in his land. The accused is also denying access to his land. He complained regarding the same with the Meripeda Police Authorities, but no action was taken. Since then, the accused have also started threatening the Petitioner.

2. The Commission took up the matter with the Superintendent of Police, Mahabubabad, Telangana on dated 05.06.2023 for ATR/Reply within 15 days.

3. As no reply/ATR received from Superintendent of Police, Mahabubabad, Telangana, the Commission fixed a Hearing on 13.06.2024 with the Superintendent of Police, Mahabubabad, Telangana.

4. On behalf of the Superintendent of Police, Mahabubabad, Telangana Additional Superintendent of Police, Mahabubabad, Telangana was present. The petitioner Shri Jarupula Ramesh and his brother were also present in the hearing.

5. The matter was examined in detail. The Additional Superintendent of Police presented comprehensive details of the case before the Commission. The petitioner Shri Jarupula Ramesh informed that the accused is constructing a temple in the victim's land. He also alleged that a false forgery case had been filed against him and he went to jail in the same. He also informed that postman, an employee of Department of Posts intentionally didn't provide him Commission's letters on time. The Additional Superintendent of Police assured the Commission that the police will make local enquiry and spot visit victim's house. He also ensured to provide security to the victim and his family.

6. After hearing the matter, the Commission recommends the following:

- Police security to be provided to the victim and his family.
- Local enquiry and spot visit to be made by the police authorities and the complaint be properly investigated. Detailed facts and action taken report to be submitted to the NCST in 15 days.
- If the same is not done, summons may be issued to the District Collector, Mahabubabad, Superintendent of Police, Mahabubabad and Superintendent of Post, Warangal Division.
- Later, if needed a spot visit may be done by the Hon'ble Member along with the officials of the Commission.
