Minutes of the Hearing chaired By Shri Jatothu Hussain, Hon'ble Member, NCST on 13.06.2024 in the case of Dr. ABS Sastry, Villa No:- 28, Nakshatra Housing Community, Behind Kata Maisamma Temple, Siddhanthi, Shamshabad, Ranga Reddy, Telangana.

A representation dated 25.04.2023 was received in the NCST from Dr. ABS Sastry R/o- Villa No- 28, Nakshatra Housing Community, Behind Kata Maisamma Temple, Siddhanthi, Shamshabad, Ranga Reddy, Telangana wherein Petitioner stated that his driver, Shri Nanavath Ravi Kumar who belongs Lambadi community is being harassed and threatened by Shri Gogineni Sai Sudarshan. He reported the incident to the police authorities along with CCTV footages. However, instead of taking action against Shri Gogineni Sai Sudarshan, the police authorities are threatening Shri Nanavath Ravi Kumar that they would implicate him in false cases if he didn't take back the case.

2. The Commission took up the matter with the Deputy Commissioner of Police, Ranga Reddy, Telangana on dated 28.06.2023 for ATR/Reply within 15 days.

3. In response to Commission's notice dated 28.06.2023, the Deputy Commissioner of Police, Cyberabad vide its letter dated 28.07.2023 reported this case as fake. On examination of reply dated 28.07.2023 of Deputy Commissioner of Police, Cyberabad, the Commission fixed a Hearing on 18.01.2024 with the Deputy Commissioner of Police, Cyberabad, Telangana.

4. Deputy Commissioner of Police, Cyberabad and ACP, Cyberabad were present in the hearing. The petitioner Dr. ABS Sastry was not present in the hearing.

5. The matter was examined in detail. The Deputy Commissioner of Police, Cyberabad presented comprehensive details of the case before the Commission. Victim Shri N. Ravi Kumar was not interested in the case, as he was used as a scapegoat by the petitioner.

6. After hearing the matter, the Commission recommends that:

- As victim Shri N. Ravi kumar was not interested in the case, Police authorities to take in writing from the victim and inform the Commission about the same.
