Minutes of the Hearing chaired By Shri Jatothu Hussain, Hon'ble Member, NCST on 13.06.2024 in the case of Dr. Mohanbabu Jatavath, Door No. 3-7-62/420, Southend Park, Mansoorabad, Saroor Nagar, District -Ranga Reddy, Telangana.

A representation dated 28.07.2022 was received in the NCST from Dr. Mohanbabu Jatavath, R/o- Door No. 3-7-62/420, Southend Park, Mansoorabad, Saroor Nagar, District - Ranga Reddy, Telangana regarding atrocity against ST by non STs by way of cheating, threatening and Police inaction against the accused. He alleged that he lodged a complaint against Shri Pentyala Venkata Subba Rao, Gurram Lakshmi and Gurram Mohan Rao to register a case under the SC/ST(PoA) Act and got acknowledgement receipt for the same from L.B. Nagar Police Station on 05.08.2021. On 18.08.2021, Shri Saidulu, Sub-Inspector of Police, L.B. Nagar ordered him to change the complaint and remove the atrocity words and sentences from the complaint. He refused to change the complaint but the SI threatened him.

2. The Commission took up the matter with the Superintendent of Police, Ranga Reddy, Telangana vide Notice dated 10.10.2022 for ATR/Reply within 15 days.

3. In response to NCST notice dated 10.10.2022, no reply was received from the Superintendent of Police, Ranga Reddy, Telangana. In this matter the Commission fixed a Hearing on 13.06.2024 with the Superintendent of Police, Ranga Reddy, Telangana and the petitioner.

4. The Deputy Commissioner of Police, Rachakonda was present in the hearing. The petitioner Dr. Mohanbabu Jatavath and his mate Shri R. Bheema Naik were also present in the hearing.

5. The matter was examined in detail. The Deputy Commissioner of Police, Rachakonda presented comprehensive details of the case before the Commission. Dr. Mohanbabu Jatavath informed that he has constructed his house as the accused were not constructing his house as per terms and conditions. He also informed that caste base discrimination was done with him by the accused.

6. After hearing the matter, the Commission recommends that:

- FIR be registered under the appropriate section of SC/ST(PoA) Act.
- Police authorities to take strict action against the accused for caste discrimination.

Action taken report may be submitted by Deputy Commissioner of Police, Rachakonda to the Commission within 30 days.
