Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi, on the representation dated 13.03.2023 of State President, Adivasi Bharath Mahasabha (ABM), Telangana, District Adilabad and State Honorary President, Telangana Tribal Welfare Ashram, Schools & Hostels ANMs Welfare Association, Hyderabad – regarding termination of services of 400 ANMs working in Tribal Welfare School and Hostels in Telangana state.

State President, Adivasi Bharath Mahasabha (ABM), Telangana, District Adilabad and State Honorary President, Telangana Tribal Welfare Ashram, Schools & Hostels ANMs Welfare Association, Hyderabad vide their representations dated 13.03.2023 has stated that the Govt. of Telangana had terminated the services of 400 ANM working in Tribal Welfare Schools & Hostels in Telangana, who were rendering their services long back. The 126 ANM were re-appointed in Adilabad District after continuous representations. The remaining ANMs left over may be reappointed and also requested for enhancement of remuneration from Rs. 4000 to Rs. 20000/-.

- 2. The NCST vide Notice of even no. dated 21.03.2023 had referred the matter to Secretary, Tribal Welfare Department, Govt of Telangana for furnishing the facts and comments. There was no reply received from the concerned department. The Commission decided to discuss the issue with the Secretary, Tribal Welfare Department, Government of Telangana and the petitioners on 26.06.2024. Accordingly, the Sitting Notice was issued on 19.06.2024 to authority and copy endorsed to petitioners for attending the sitting.
- 3. In the sitting, the Secretary, Tribal Welfare Department, Government of Telangana was personally present and petitioners were not present. The Secretary informed had informed about the background for the appointment of ANMs in Ashram Schools and stated that Government of Telangana had sanctioned ANM post in each Ashram Schools from the year 2023 onwards and 623 ANMs have been appointed with remuneration of Rs. 22,750/- per month each. The department had given directions to District Collectors of Non-ITDA and Project Officers of ITDS to give preference to candidates who earlier worked as ANM.
- 4. After the discussion with Secretary, Tribal Welfare Department, Government of Telangana, the following points were recommended for taking up action by Tribal Welfare Department, Government of Telangana and suggested to submit ATR within one month from receipt of the minutes:
 - (i) The list of 461 ANMs along with their caste category, who were engaged on part time basis on Rs. 4000/- remuneration and were terminated earlier.

(ii) The list of 623 ANMs who had been appointed in the year 2023 along with their caste category and it may also be submitted that how many ANMs who were terminated earlier have been re-appointed.
