Minutes of the Sitting held under the Chairmanship of Shri Jatothu Hussain, Hon'ble Member, National Commission for Scheduled Tribes at Lok Nayak Bhawan, New Delhi regarding suspension and transfer by of Shri. M Hariya Naik, Sr. Assistant, by administration of Sri Brahmaramba Mallikarjuna Swamy Varla Devasthanam, Srisailam, District-Kurnool (Andhra Pradesh) – an online representation dated 04.08.2024 of Shri B. Chekre Naik, State Chairman, All India STs Employees Association, Andhra Pradesh State Committee, Vijaywada (Andhra Pradesh).

State Chairman, All India STs Employees Association, Andhra Pradesh State Committee, Vijaywada (Andhra Pradesh) vide online representation dated 04.08.2021 had alleged about the harassment of ST employee namely Shri M. Hariya Naik, Sr. Assistant by the administration of Sri Brahmaramba Mallikarjuna Swamy Varla Devasthanam, Srisailam, District Kurnool. He alleged the victim was suspended by the authority and now he has been reinstated and transferred to another place, as he belongs to ST category.

2. NCST vide Notice of even no. dated 17.01.2022 had referred the matter to the Department of Revenue (Endowments), Govt. of Andhra Pradesh, Guntur for furnishing the facts and comments. There was no reply from the concerned authority. The Commission decided to discuss the issue with Commissioner, A.P. Endowments Department and the petitioner on 26.06.2024. Accordingly, the Sitting Notice of even no. was issued on 19.06.2024 to concerned authority and petitioner & victim.

3. The Commissioner, A.P. Endowments Department, Govt. of Andhra Pradesh and the petitioner & victim were present. The petitioner alleged that administration had taken wrong action, due to which victim suffered. The department did not initiate any inquiry against the employee who was actually involved in the misappropriation of Rs. 41.69 Lakhs, as alleged administration. The Commissioner, A.P. Endowments Department, Govt. of Andhra Pradesh informed that petitioner has filed the case before the Hon'ble High Court. In pursuance of the orders, the victim (Shri M. Hariya Naik) was promoted as Superintendent and he reported on duty on 22.02.2024.

4. After discussion with both parties, the following points were recommended and it was suggested to AP Endowment Department to furnish the ATR within one month of receipt of minutes:

- (i) A Committee may be constituted to look into the incident to find out the role of senior officials and their relatives, as alleged by the petitioner and victim in the sitting. An ST member may be nominated in the inquiry committee.
- (ii) The action taken by the management of Sri Brahmaramba Mallikarjuna Swamy Varla Devasthanam, Srisailam on the Superintendent and other senior officials at the time of incident, to be submitted to NCST.
- (iii) The due allowances of victim, during his suspension period may be paid, as per rule (with interest, if possible).
- (iv) The promotion of the victim (Shri M. Hariya Naik) may be re-considered from 2018, as per rule.
