
Shri V. Pradeep Kumar, Member, Kerala Vanavasi Vikas Kendra, District - Palakkad (Kerala) vide representation dated Nil has alleged that the reservation policy is not implemented in special recruitment conducted by the Department for Para-medical, Nursing and other Non-Teaching staff by administration of Medical College, Palakkad (Kerala).

2. The NCST vide Notice of even no. dated 15.12.2023 has referred the matter to Addl. Chief Secretary, SC and ST Development Department, Govt. of Kerala, for furnishing the facts and comments. There was no response from the department. Hence, Commission decided to discuss the issue with Additional Chief Secretary, Govt. of Kerala and the petitioner on 26.06.2024. Accordingly, Sitting Notice of even no. was issued on 19.06.2024 to concerned authority and petitioner. Addl. Chief Secretary, SC and ST Development Department, Govt. of Kerala, vide email dated 24.06.2024 has furnished the facts and comments.

3. The Addl. Chief Secretary, SC and ST Development (F) Department, Govt. of Kerala was present and petitioner did not appear in the sitting. The concerned authorities reiterated the facts submitted by email dated 24.06.2024 and informed that the RRs for the various posts is under active consideration. Till the time RRs are framed, the work is being carried out through contractual employees.

4. After the discussion, the following points were recommended for taking up action by concerned department and suggested to submit the ATR by 3 months from the date of Sitting -

1. SC and ST Development (F) Department, Govt. of Kerala may finalise the RR rules preferably within 3 months.
2. The date of establishment of Integrated Medical Science College, Palakkad (Kerala) in the State may be provided.
3. The ST reservation may be maintained in various posts of the Medical College, as per reservation provided by Govt. of Kerala to ST in the state.
