
A representation dated 01.09.2023 of Shri Abdul Rashid Qadri, Vill- Behrote, Tehsil- Thanamandi, Distt.- Rajouri, Jammu & Kashmir was received in the NCST from the Under Secretary, MoTA, New Delhi, regarding caste based abuse, violence, oppression, physical assault and threatened to kill by a group of goons, village Behrote, Tehsil- Thanamandi, Distt.- Rajouri, Jammu and Kashmir. The petitioner alleged that a group of goons from village Behrote, Tehsil- Thanamandi, Distt. Rajouri, Jammu and Kashmir are assaulting, harassing and committing serious crimes against him and his family members. They have also grabbed a part of their land. These people are trying to harass physically and sexually of the female members of his family, throw stones at them etc. He requested the Commission to intervene the matter.

2. The Commission took up the matter with the Superintendent of Police, Distt.- Rajouri, Jammu & Kashmir on dated 13.09.2023 for ATR/Reply within 15 days.

3. As No any reply/ATR received from Superintendent of Police, Distt.- Rajouri, Jammu & Kashmir, the Commission fixed a Hearing on 27.06.2024 with the Superintendent of Police, Distt.- Rajouri, Jammu & Kashmir

4. The Superintendent of Police, Rajouri was present on video call. The petitioner was not present in the hearing.


5. The matter was examined in detail. The Superintendent of Police, Rajouri presented comprehensive details of the case before the Commission.
